**DEVELOPER SDK COMMERCIAL LICENSE AGREEMENT**  
**AMP® L3D MP3 DECODER SOFTWARE DEVELOPER'S KIT (SDK)**

This LICENSE Agreement applies to the computer software and related documentation and materials collectively known as AMP® L3d MP3 Decoder And Software Developer's Kit (SDK) (hereinafter collectively referred to as "SOFTWARE" and/or "AMP® L3d SDK"), which includes without limitation both "Low-Level" and "OCX" versions of the AMP® L3d codec and related documentation and materials. THIS LICENSE IS SUBJECT TO MODIFICATION OR REVISION WITHOUT ADVANCED NOTICE. In addition, other special terms and conditions for this licensing agreement may apply. Please visit <http://www.playmediasystems.com> to obtain the latest revision of this License and to obtain more information and other licensing restrictions and/or limitations pertaining to the AMP® L3d decoder and SDK (and for information regarding use of other PlayMedia Labs and/or PlayMedia Systems, Inc. software products).

BEFORE YOU (HEREINAFTER REFERRED TO AS "LICENSEE", "YOU", OR "YOUR") USE THE SUBJECT SOFTWARE OR ANY OTHER SOFTWARE DISTRIBUTED WITH THIS LICENSE AGREEMENT, CAREFULLY READ THE TERMS AND CONDITIONS OF THIS AGREEMENT. BY USING THE SUBJECT SOFTWARE OR RELATED DOCUMENTATION OR MATERIALS, YOU ARE THEREBY WILLFULLY CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS AND CONDITIONS OF THIS AGREEMENT, DO NOT USE, REPRODUCE, OR DISTRIBUTE THE SUBJECT SOFTWARE, NOTIFY PLAYMEDIA BY E-MAIL OR REGISTERED U.S. MAIL OF YOUR INTENTIONS, AND DESTROY ALL COPIES OF THE SOFTWARE FROM YOUR COMPUTER MEMORY, HARDRIVE, AND OTHER STORAGE MEDIA. PLAYMEDIA HEREBY PLACES YOU ON NOTICE THAT PLAYMEDIA WILL PURSUE ANY AND ALL REMEDIES AVAILABLE TO IT, INCLUDING WITHOUT LIMITATION, CRIMINAL PROSECUTION, INJUNCTIONS, AND/OR CIVIL ACTIONS, AGAINST ANY INDIVIDUAL OR ENTITY, INCLUDING LICENSEE, WHO BREACHES THIS AGREEMENT OR UNLAWFULLY INFRINGES UPON ANY OF PLAYMEDIA'S RIGHTS, WHETHER SUCH RIGHTS OR REMEDIES BE BORN FROM U.S. LAWS, APPLICABLE INTERNATIONAL LAWS, AND/OR INTERNATIONAL TREATIES.

- 1. Restricted Developer's License.** Subject to the terms and conditions of this Agreement, and any revision(s) thereof, PlayMedia Labs and/or PlayMedia Systems, Inc. (collectively referred to hereinafter as "PlayMedia" or "PlayMedia Group") hereby grants Licensee a non-exclusive, non-transferable restricted right and license to install, use and distribute the SOFTWARE to design and develop MPEG1, Layer-3 ("MP3") audio playback computer software. PlayMedia hereby reserves all rights not expressly granted to Licensee by this Agreement.
- 2. Redistribution of Software Must Include License.** Licensee's limited rights and conditions to distribute the SOFTWARE, or any portion thereof, are subject to the distribution and marketing terms and conditions described and set forth in this Agreement. Licensee may not sell, rent, lease, loan, sublicense, transfer, distribute, or transmit over a network or from one computer to another, the SOFTWARE in whole or in part, or any derivation thereof, without

also including a copy of this License Agreement in its entirety with such distributed or transmitted SOFTWARE or derivation thereof. Failure to include a copy of this License Agreement shall constitute a material breach of this License Agreement by Licensee.

### 3. **Marketing/Distribution.**

3.1. Licensee acknowledges and agrees to expressly include, in some reasonably prominent place within the visible Graphical User Interface (GUI) of the Licensee's subject Application (or other prominently visible location agreed to by PlayMedia), the following copyright notice:

AMP, the AMP logo, Advanced Multimedia Products, and PlayMedia are trademarks of PlayMedia Labs and/or PlayMedia Systems, Inc. All Rights Reserved.”

3.3. Licensee acknowledges and agrees that PlayMedia, at its sole election and at any point now or in the future, may feature, display, and/or reference Licensee's software products and/or Applications derived from the SOFTWARE and/or other AMP® L3d related technology--including, without limitation, any commercial or shareware software mp3 player products and/or services developed by Licensee--via a direct Website-link to a PlayMedia product vending Web-page located on any PlayMedia-controlled Website, including, without limitation, <http://www.playmediasystems.com>.

3. **Restrictions Against Reverse-Engineering.** Except by prior written explicit permission from PlayMedia, Licensee may not de-compile, reverse engineer, tamper with, disassemble or otherwise ascertain the nature of or reduce the SOFTWARE to a human-perceivable form.

4. **Responsibility for Testing.** Licensee acknowledges and agrees that it is solely responsible for selecting any beta-testing and/or development environment, configuring or interfacing of the SOFTWARE with Licensee's own software product(s) and/or any third-party software in Licensee's operating and test environments, as well as any results of such beta-tests.

### 5. **Licensee's Indemnity.**

5.1. Licensee acknowledges and agrees to indemnify, hold harmless, and defend PlayMedia, and its subsidiaries and licensor(s), from and against any claims or lawsuits, including attorney's fees, that arise out of or result from the use or distribution of Licensee's own Application(s) developed with and/or containing portions of the SOFTWARE;

5.2. Licensee assumes full responsibility for selecting any beta-test or development site, informing Licensee's employees (and, if necessary, appropriate or required by law, Licensee's Licensee(s) or end-users) of the material provisions of this Agreement. PlayMedia will not provide any on-site service or support for the SOFTWARE at a beta-test or development site. PlayMedia accepts no responsibility whatsoever for Licensee's use of the SOFTWARE. The subject SOFTWARE is currently under development and testing by PlayMedia. Licensee hereby acknowledges that the SOFTWARE may contain “bugs” and other errors that could adversely affect the use or

performance of the SOFTWARE; the subject software may contain inoperable features; the materials may contain errors and may be incomplete; and the Licensee should take extra care in preserving its data in order to avoid any loss of data as a result of using the programs. PlayMedia disclaims all responsibility for such errors and for any experimental modifications to the SOFTWARE by Licensee for Licensee's own purposes whether the modifications are made by PlayMedia, a third-party or Licensee. Licensee hereby indemnifies PlayMedia and holds it, its officers, directors, employees and agents harmless from, and will defend them against, any and all claims arising out of the beta-testing and/or development of works derived from the SOFTWARE by Licensee.

## 6. Confidentiality/Non-Disclosure.

- 6.1. **Confidential Information.** Licensee agrees that the SOFTWARE and any information concerning the SOFTWARE, including its nature and existence and any other information disclosed by PlayMedia to Licensee, including but not limited to information learned by Licensee from PlayMedia employees, agents or through inspection of PlayMedia's property, products, designs, business plans, business opportunities, finances, research, development, know-how, personnel, or third-party confidential information disclosed to Licensee by PlayMedia, will be considered and referred to collectively in this Agreement as "Confidential Information", and constitutes valuable trade secrets of PlayMedia and/or its licensors.
- 6.2. **Exclusions.** Confidential Information does not include information that: (a) is now or subsequently becomes generally available to public through no fault or breach on the part of the Licensee or related persons; (b) Licensee can demonstrate to have had rightfully in its possession prior to disclosure to Licensee by PlayMedia; (c) is independently developed by Licensee without the use of any Confidential Information; or (d) Licensee rightfully obtains from a third-party who had the right to transfer or disclose it.
- 6.3. **Ownership of Confidential Information.** All Confidential Information remains the sole and exclusive property of PlayMedia. Licensee has no implied licenses or other rights in the Confidential Information not specifically granted herein.
- 6.4. **Non-Disclosure and Non-Use.** Licensee will not disclose, publish, or disseminate Confidential Information to anyone other than those of its employees with a demonstrable need to know, who have binding, written confidentiality obligations to Licensee that protect such Confidential Information against unauthorized disclosure. Licensee further agrees to take reasonable precautions to prevent any unauthorized use, disclosure, publication or dissemination of Confidential Information. Licensee agrees not to use Confidential Information for its own or any third-party's benefit without the prior written approval of an authorized representative of PlayMedia in each instance. The results, operating data and test information arising from the Beta Test will be made available in writing to PlayMedia, promptly upon PlayMedia's reasonable request.

7. **Equitable Relief.** Licensee hereby acknowledges that unauthorized disclosure or use of Confidential Information could cause irreparable harm and significant injury to PlayMedia that may be difficult to ascertain. Accordingly, Licensee agrees that PlayMedia will have the right to obtain immediate injunctive relief to enforce obligations under this Agreement in addition to any other rights and remedies it may have.

8. **Royalty Rates/Licensing Fees.**

8.1. **DEFAULT ROYALTY LICENSING FEE.** Absent a separately negotiated and mutually-agreed to Schedule "P" Licensing Addendum or other express agreement for consideration to PlayMedia for Licensee's use of the SOFTWARE, the default royalty licensing fee payable to PlayMedia shall be **twenty percent (20%)** of any and all gross revenues generated and/or earned by Licensee's use or distribution of the SOFTWARE, as defined in paragraph 8.2, herein below.

8.2. **Revenues Defined.** Revenues shall be defined as including without limitation, any and all revenue, income, and profits generated or earned directly or indirectly from Licensee's use of the SOFTWARE, from the sale of Licensee's subject Application itself and/or any revenue generated from advertising, merchandising, or any other income generated due to the subject Application in any medium, including, without limitation, the "Home Page" or other web-pages of the Website(s) containing or offering the Application, and all other web-pages of the Website which are linked to any Web page offering or promoting the Application.

8.3. **Schedule "P" (Licensing Schedule).** Royalties/License Fees must be properly determined in advance of any distribution, marketing, transferring, transmitting, selling, renting, leasing, launching, deployment, and/or other use of the Application by the Licensee or third-party. If Licensee wishes to negotiate with PlayMedia to obtain a license under different terms and conditions and/or royalty rates or licensing fees, such negotiated and mutually agreed to terms and conditions must be expressly stated in a separate **Schedule "P"** sent by PlayMedia to Licensee upon prior express notification by Licensee which discloses such desire for a customized license. In creating the Schedule "P", PlayMedia may determine upon its discretion, based on the completion by Licensee of a simple Questionnaire, what the percentage of "value-add" MP3 decoding is to the subject Application or Licensee revenue stream. This amount may be calculated based upon the number of audio formats supported (where a value/weight is given to each format and where MP3 would, due to its importance in the market, receive weighting equal to CDDA playback). Based on this percentage of value that MP3 decoding adds to the Application, factored into the Revenues generated by its overall marketing, may determine the unique Royalty/License Fee for which PlayMedia would accept as fair. Please contact PlayMedia ([licensing@playmediasystems.com](mailto:licensing@playmediasystems.com)) for more information about obtaining a separately negotiated Schedule "P" addendum to this License.

8.4. The royalties shall be payable on a monthly (if over US\$500per month) or quarterly (if less than US\$500) basis, payable to PlayMedia Systems, Inc. (if Licensee is U.S. based) or PlayMedia Labs (if Licensee is non-U.S. based). Such royalties shall be paid to PlayMedia either through an electronic bank-wire money transfer or by mailing such royalty amount to the appropriate Bank or P.O. Box designated below.

- 8.5. With each royalty payment there shall be an itemized accounting for each transaction on a Microsoft® Excel™ spreadsheet containing the following columnar headings: DATE RECEIVED / PAYMENT METHOD (e.g., check, credit card, or via third-party register) / SALE TYPE (commercial or personal) / Amount.
- 8.6. **5,000 or More Distributions or Registered End-Users Requires Registration.** In the event that the number of distributed copies or end-users of Licensee's subject Application exceeds five thousand (5,000) units or registered users, Licensee must immediately notify PlayMedia of such fact within five (5) business days of such occurrence. PlayMedia hereby places Licensee on further notice that in such event Licensee may be required to obtain a separate license under new or different terms and conditions and/or royalty rates/licensing fees owed. PlayMedia further reserves the right to terminate said license without cause by delivering fifteen (15) days' advanced written notice to Licensee of such intent to terminate the Agreement.
9. **Payment Enforcement Mechanism.** In the event that Licensee's Application is licensed or sold to third-parties as "shareware" or other similar commercial method of licensing rather than made freely available as "freeware", Licensee must enforce payment by engineering, prior to the distribution, transfer, or marketing of the Application, a methodology whereby the AMP® MP3-player functionality will be unavailable to the end-user/licensees of the Application after (a) either a 30-day or 30-use trial period, or (b) upon implementation of another significant means of limiting/disabling the AMP® L3d MP3 play-back functionality which must be approved by PlayMedia before Licensee distributes, transfers, or markets Licensee's Application. (This requirement is used to enforce third-party licensing payment by the end-user(s) so that both PlayMedia and Licensee can maximize compensation for their fair and substantial work done.) If such limiting/disabling mechanism is not implemented by Licensee, this Agreement shall be immediately rendered null and void unless a waiver for this provision is expressly agreed to in writing by PlayMedia.
10. **Customer Support.** Support may be made available to Licensee via email inquiry from Licensee to [ampsupport@playmediasystems.com](mailto:ampsupport@playmediasystems.com) at the rate of not less than US\$75.00 per hour, billable in quarter-hour increments and payable by approved major bank credit card or cashier's check. PlayMedia reserves the right to change the aforementioned hourly-rate at any time without advanced notice.
11. **Right of Promotion.** Licensee shall permit, without limitation, PlayMedia to advertise and promote Licensee's Application and other subject use of PlayMedia's SOFTWARE, and shall make available to PlayMedia graphics, text and logos necessary to properly support such promotion.
12. **Customer Database.** If a database of customers of the Licensee's product containing the SOFTWARE is maintained by the Licensee then, at PlayMedia's own option, that database shall also be made available for marketing purposes by PlayMedia unless precluded by prior agreement, a published consumer-privacy policy, or prevailing consumer privacy laws.
13. **Third-Party Representations.** Licensee shall not under any circumstances make any offers, proposals or engage in any negotiations with any third-party regarding any product containing SOFTWARE without PlayMedia's express prior written authorization.

**14. Disclaimer of Warranty.**

- 14.1. YOU EXPRESSLY ACKNOWLEDGE AND AGREE THAT USE OF THE SOFTWARE IS AT YOUR SOLE RISK. THE SOFTWARE AND THE CONFIDENTIAL INFORMATION IS PROVIDED TO LICENSEE “AS IS,” WITHOUT ANY REPRESENTATION OR WARRANTY, EITHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, ANY REPRESENTATIONS OR WARRANTIES REGARDING MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT, OR THE SUBJECT SOFTWARE’S PERFORMANCE, CONDITION, CERTIFICATIONS OR COMPLETENESS. This disclaimer of any and all warranties must be communicated to employees and to Licensee’s own sub-licensees, customers, and end-users (where permitted and appropriate) by Licensee, who hereby indemnifies and holds PlayMedia harmless from and against any failure to so inform said parties.
- 14.2. Licensee acknowledges that PlayMedia may not have publicly announced the availability of the SOFTWARE, or derivations thereof, that PlayMedia has not promised or guaranteed to Licensee that such SOFTWARE will be announced and made available for sale to anyone in the future, and that PlayMedia has no express or implied obligation to develop and to announce or produce the SOFTWARE, or any similar or compatible product or derivation.
- 14.3. Licensee expressly acknowledges and agrees that any testing or experimenting that it performs with respect the SOFTWARE is entirely at Licensee’s own risk, expense, and liability.
15. **Export Restrictions.** Licensee certifies that no Confidential Information nor any portion thereof will be exported to any country in violation of the United States Export Administration Act and regulations thereunder, as applicable.
16. **Reservation of Rights.** PlayMedia reserves and owns, or has the right to exercise, all rights in the SOFTWARE and the Confidential Information. Nothing contained in this Agreement grants or confers, or shall be construed to grant or confer, any rights in the SOFTWARE or the Confidential Information by license or otherwise, expressly or by implication, except the express limited testing rights set forth herein.
17. **Ownership.** Licensee acknowledges that the SOFTWARE and all copyrights, trademarks and other intellectual property rights with respect thereto, including without limitation, any and all source or executable computer software code, binary code, images, photographs, animations, video, audio, music, text, and “applets” incorporate into or included with the SOFTWARE, are and will at all times be the intellectual property of PlayMedia (and/or relevant third-party copyright holders/licensor(s)), even if suggestions or comments made by Licensee are ultimately incorporated into subsequent versions of the SOFTWARE or derivations thereof by PlayMedia. Any unauthorized use of PlayMedia’s products or intellectual property is strictly prohibited and PlayMedia, and/or its subsidiaries, licensors and/or other interested parties in its intellectual property will vigorously enforce and protect its rights under any and all applicable laws and treaties, worldwide. Licensee agrees to abide by and be bound by all applicable United States copyright and other applicable

intellectual property laws regarding the SOFTWARE in addition to any applicable foreign laws.

18. **Use of “AMP” Name In Licensee’s Product** (e.g., “WinAMP”, “MacAMP™”). Licensee hereby acknowledges and agrees that the trademark brand names “AMP” and “PlayMedia” are owned by and exclusively for the use of PlayMedia Group/PlayMedia Systems, Inc. Any designation or use of the “AMP” trademark by Licensee (or equivalent use of the brand name Advanced Multimedia Products) in any brand name of Licensee’s product must be expressly authorized by PlayMedia in writing by prior to such trademark use and/or designation by Licensee. (Such permission is generally not granted due to potential market/consumer confusion issues associated with trademark usage). However, Licensee must display the “AMP®” trademark logo (to be provided by PlayMedia) with the words “Powered by AMP®” reasonably displayed somewhere prominently on the front GUI of Licensee’s Application. If PlayMedia determines that such demarcation is not reasonably feasible (determined on a case by case basis), the credit:

must appear in the intellectual property credits for Licensee’s Application. Should the license terminate for any reason, or if any material portion of the SOFTWARE code is removed from Licensee’s Product, then Licensee hereby agrees to immediately cease and desist in any further use of any trademark rights granted by PlayMedia and use of any other PlayMedia trademarks, including without limitation, further distribution of any of Licensee’s subject Application(s)/Product(s) containing the name “AMP®”.

19. **Third-Party Patents and Copyrights.** The recording and/or playback features of this SOFTWARE are intended only for use with public-domain or properly licensed content and content creation tools. You may require a patent, copyright, or other license from a third party to create, copy, record or save content files for playback by this Software or to serve or distribute such files to be played back by this Software. Moreover, PlayMedia does not represent or warrant that the SOFTWARE is free of infringement of, or not subject to, any third-party patents; commercial implementations of MPEG-1 and MPEG-2 decoders are subject to royalty fees to the patent holders of either the Fraunhofer Institute (IIS) of Erlangen, Germany or Thomson Multimedia of Paris, France. Many of these patents are general enough such that they are unavoidable regardless of implementation design, and some may apply to software implementations. 20. **Term; Termination.**

- 20.1. PlayMedia may terminate this License at any time and for any reason by delivering thirty (30) days' advanced written notice to Licensee of such intent to terminate the Agreement. In such event, Licensee must destroy any and all copies of the SOFTWARE, any and all component parts thereof, and any derivations thereof (including without limitation, Licensee’s own products containing any portion of the

subject SOFTWARE code), and Licensee must send a written return-receipt requested (certified mail) notification to PlayMedia that such actions have been taken by Licensee.

- 20.2. If Licensee desires to cease and desist in any way using (including, without limitation, modifying/creating derivations of, selling, renting, leasing, loaning, sublicensing, transferring, or distributing) the SOFTWARE or any material portion of the AMP® Code, Licensee must notify PlayMedia in writing at least thirty (30) days in advance of the end of the month in which Licensee desires to cease and desist in such use and distribution of the SOFTWARE. In such event, Licensee must destroy any and all copies of the SOFTWARE, any and all component parts thereof, and any derivations thereof (including without limitation, Licensee's own products containing any portion of the subject SOFTWARE code), and Licensee must send a written return-receipt requested (certified mail) notification to PlayMedia that such actions have been taken by Licensee.
- 20.3. Any termination of this Agreement, whether by Licensee or by PlayMedia, and/or any unilateral cessation of marketing of the SOFTWARE by Licensee does not relieve Licensee of any of its accounting or payment obligations set forth in this Agreement, or for any and all amounts collected after the end of active marketing of the SOFTWARE in products, or where residual sales of Licensee's subject product(s) occur at any time subsequent to such termination.
- 20.4. In any case of termination, all restrictive conditions of this Agreement shall indefinitely survive its termination (including, without limitation, Licensee's duty to indemnify PlayMedia, the restriction against disclosure of confidential information by Licensee, and the restriction against competition with PlayMedia). Upon any termination of the license granted herein, Licensee will (a) erase or otherwise destroy all copies of software containing any portion of the SOFTWARE that are fixed or resident in memory in computers owned or controlled by Licensee, and (b) return to PlayMedia all other existing copies (including original copies) of the SOFTWARE in the possession or under the control of Licensee, together with a description of the circumstances which resulted in the destruction of any such copies that were once (but no longer are) in the possession or under the control of Licensee.
21. **Disclaimer of Liability.** TO THE MAXIMUM EXTENT PERMISSIBLE BY APPLICABLE LAW, PLAYMEDIA SHALL HAVE NO LIABILITY TO LICENSEE OR ANY THIRD PARTY WITH RESPECT TO ANY LIABILITY, LOSS, OR DAMAGE CAUSED OR ALLEGED TO BE CAUSED, DIRECTLY OR INDIRECTLY, BY THE SOFTWARE OR ANY OTHER SOFTWARE OR DOCUMENTATION PROVIDED TO LICENSEE BY PLAYMEDIA; AND LICENSEE WILL INDEMNIFY AND HOLD PLAYMEDIA HARMLESS FROM SUCH LIABILITY. IN NO EVENT WILL PLAYMEDIA BE LIABLE FOR LOST DATA OR INFORMATION, LOSS OF BUSINESS OR ANTICIPATORY PROFITS, BUSINESS INTERRUPTION, OR ANY PECUNIARY, SPECIAL, INDIRECT, CONSEQUENTIAL OR INCIDENTAL DAMAGES RESULTING FROM THE USE OR INABILITY TO USE THE SOFTWARE, REGARDLESS OF WHETHER PLAYMEDIA HAS BEEN INFORMED BY LICENSEE OF THE POSSIBILITY OF SUCH DAMAGE(S).

22. **Entire Agreement.** This Agreement constitutes the entire Agreement, which Agreement pertains to the development, use and/or distribution by Licensee of software products containing portions of the SOFTWARE code; this Agreement supersedes all prior or contemporaneous oral or written agreements concerning such SOFTWARE. This Agreement may not be amended except by the written agreement signed by authorized representatives of both parties.
