THIS LICENSE GOVERNS YOUR USE OF (1) THIS UPDATER SOFTWARE AND (2) THE MODIFIED VERSION OF ANY SOFTWARE THAT RESULTS FROM YOUR USE OF THIS UPDATER SOFTWARE. THIS LICENSE REPLACES ANY PRIOR SOFTWARE LICENSE AGREEMENT(S) THAT WERE DISTRIBUTED WITH ANY SOFTWARE THAT YOU MODIFY BY USING THIS UPDATER SOFTWARE. 1. License. (ix) distribute the Distributable Software incorporated in any HyperCard stack or stand-alone application created by you only to distributors or end users who are subject to binding written agreements which are consistent with this License, are no less protective of Apple's rights in the Distributable Software than this License is of Apple's rights in the Apple Software, grant only a non-exclusive right to use the Distributable Software incorporated in HyperCard stacks or stand alone applications created by you on a single computer, and include warranty disclaimer and disclaimer of liability provisions with respect to the Distributable Software which are substantially similar to those set forth in this License.
