## **Instructions**

The license and the template have been zipped using Norton Desktop 3.0. If you got this far, then you must already know how to unzip files. The template is designed for use in Microsoft Word for Windows version 6.0.

When you want to create a document, click on File, New, then choose the template Matrghts. The template will start, giving you some instructions. When you're done filling in the fields, the template will bring you right back to the first field.
