Payoff Rules

The payoff for a winning combination is shown on the chart below.

All payoffs are given in coins. The actual dollar amount will change depending on the dollar value of the machine. During play, the dollar amount will be displayed on the status bar at the bottom of the screen when a winning combination occurs.

Coins Played

The *Coins Played* display shows the number of coins deposited.

Spin Button

The *Spin* button spins the wheels.

Bet One Button

The *Bet One* button will deposit one coin.

Slot Display

This is the slot display. When the arm is pulled or the spin button is pushed they will spin. If they stop in a combination shown on the payoff wheel you win.

Bet Max Button

The *Bet Max* button will deposit three coins and spin the wheels.

Coins Won

The *Coins Won* display shows the number of coins won on the last turn.

Insert Coin Slot

Click on the *Insert Coin Slot* with the left mouse button to deposit one coin. It is the same as the Bet One button.

The Arm

Click on the *Arm* with the left mouse button to spin the wheels. It is the same as the Spin button.

Dollar Value

The machines dollar value. This can be changed using the options menu.

Coin Tray

This is the tray that catches the coins when you win.
