Dear Open Systems Environment Implementors' Workshop (OIW) Participant:

Plan to join us for the December 12-15, 1994 Workshop. The cutoff date for advance registration is November 18.

The Workshop continues to work on a suite of IPS profiles. Several will be progressed to Stable and some new ones will be considered for inclusion as Working Agreements. This work may become a candidate for inclusion in a future Federal Standard, Profiles for Open Systems Internetworking Technologies (POSIT).

The Conformance Testing SIG will continue work on Interoperability Testing methodologies. This is part of their newly expanded Charter program of work. Active participation of European Open Systems Workshop's (EWOS) Conformance Testing SIG is expected.

The Healthcare SIG is expanding its work into areas of Healthcare Information Infrastructure and the Electronic Commerce Study Group will be working on the next draft of their EDI Infrastructure Document.
