### **Undo**

The image in the current window is restored to its previous status.

Displays a short tutorial and other information about using Windows on-line Help.

## Converting from One File Format to Another

RezSolution lets you work with .BMP, .RLE, and .PCX file formats. If a file currently uses one of these formats, you can convert it to one of the other two formats.

### To convert a file from one format to another:

1. Open the existing graphic file.

If it is already open, make sure it is the active document window.

2. Choose Save As... from the File menu.

A File Save As dialog box appears.

3. Select an option button to indicate the format to which you want to convert the file: .BMP, .RLE, or .PCX.

The extension of the filename in the Filename text box automatically changes to reflect the selected file format.

4. Choose Ok.

The file is converted and saved under the new filename. (The original file, which has a different filename extension, still exists.)



## Scaling Images Proportionately

There are two ways to scale images proportionately. You can enter new values in the Width and Height apply data boxes or you can enter a new value in the Zoom % apply data box.

### To enter new height and width values for a graphic:

1. Load the graphic into RezSolution.

If it is already loaded, make it the active document window.

2. Enter a new value in the Height apply data box.
3. Enter a new value in the Width apply data box.

Make this value proportionate to the Height value. That is, if you tripled the height, triple the width.

4. Click on the Apply button.

The new height and width values are applied.

The file, however, is not permanently changed until you save it with the changes. You can save the changes, experiment with additional changes, or undo the changes to return the graphic to its original state.

### To enter a Zoom % for a graphic:

1. Load the graphic into RezSolution.

If it is already loaded, make it the active document window.

2. Enter a new value in the Zoom % box.

Use a value greater than 100 to increase the image size proportionately. Use a value that is less than 100 to decrease the image size.

3. Click on the Apply button.

The image size is increased or decreased as indicated. The values in the Width and Height apply data boxes are automatically adjusted to reflect the new image size.

As with any changes made with the Apply button, the file is not permanently changed until you save it with the changes.

## Stretching or Reducing Images

You can stretch or reduce an image by entering new values in the Width and Height apply data boxes.

When RezSolution expands or reduces an image it changes pixel values. Pixels are proportionately added or subtracted to fit into the new image size. Be aware that stretching or shrinking an image may effect the clarity of the picture.

### To enter new height and width values for a graphic:

1. Load the graphic into RezSolution.

If it is already loaded, make it the active document window.

2. Enter a new value in the Height apply data box and/or the Width apply data box.

As an example, if you indicate a larger width value and do not change the height value, the image will be stretched horizontally.

3. Click on the Apply button.

The new height and width values are applied.

The file, however, is not permanently changed until you save it with the changes. You can save the changes, experiment with additional changes, or undo the changes to return the graphic to its original state.

**Note:** When RezSolution expands or reduces an image it changes pixel values. Pixels are proportionately added or subtracted to fit into the new image size. Be aware that stretching or shrinking an image may effect the clarity of the picture.

## Cropping Images

RezSolution allows you to crop an image. In effect, you select the rectangular part of the image that you want to retain. Any area not selected will not be part of the image.

1. Load the graphic into RezSolution.

If it is already loaded, make it the active document window.

2. Move the cursor into the active document window and position it at the top left corner of the area you want to select. (The cursor appears as a crosshair with a box in the lower right quadrant.)
3. Press and hold the left mouse button and drag down and to the right. (Hold down the Shift key to draw a square.)
4. Release the mouse button when the rectangle is the desired size.
5. Choose Copy from the Edit menu.

The selected image is copied to the Clipboard and can be seen in the Clipboard Viewer.

You can work with the cropped image in one of two basic ways:

- Manipulate the image in the Clipboard Viewer and optionally save it to a new file.
- Choose Paste from the Edit menu to paste the image from the Clipboard back into the document window from which it was copied. (When you do this, the original image is completely replaced by the pasted image.)

## **Converting 16-Color .PCX Files from Windows 2.x to 3.0**

16-color .PCX files created in Microsoft Windows Version 2.x have the red and blue color data reversed. The colors in the image are wrong when displayed in Windows 3.0. RezSolution solves this problem with an option to swap (correct) the red and blue color data. The graphic image then appears normal in Windows 3.0.

There are two Option menu commands that let you swap the red and blue color data: Swap Red and Blue and Swap Red and Blue On Open.

### **To swap red and blue in one file:**

1. Open the file you want to convert, or click on the appropriate document window to make it the active window.

Initially, the colors will not appear properly.

2. Choose Swap Red and Blue from the Options menu. (This command is only available if the graphic file was created in Windows 2.x.)

The colors in the graphic are reversed and the image appears as intended.

If you plan to convert several 16-color files created in Windows 2.x, you can choose Swap Red and Blue On Open from the Options menu. This toggles on the feature so that every time you open a file the swap is performed automatically. The feature does not affect files that are not 16-color graphics created in Windows 2.x.

## Converting Black and White to Color

RezSolution lets you convert a black and white graphic file to color if you are working on a color system. For example, if you are working on a system that supports 16 colors, you can open a black and white graphic and convert it to 16 colors.

When you convert a file, it does not immediately appear colored. In effect, it becomes a color graphic that uses only two colors, black and white. Once the file has been converted and saved, you can then open the file in a paint program and use the color palette to add color to the graphic.

### To convert an image from black and white to color:

1. Load the image into RezSolution.

If it is already loaded, make it the active document window.

2. Enter the appropriate value in the Colors apply data box.

For example, enter 16 if you are working on a 16 color system and want to convert the image to 16 colors.

3. Click on the Apply button.

The image does not appear to have changed, however, the palette information in the header of the file has changed. When you save and open the file in a graphic editor such as Paintbrush, a color palette will be available and you can add color to the graphic.

## Converting Color to Black and White

RezSolution allows you to convert your graphics to black and white without losing image definition. Instead of taking colors and translating them into either black or white, it substitutes different hatch patterns for the different colors in the graphic file. You can choose between levels of hatch patterns when converting to black and white.

For example, your 16 color image may be converted to solid white and solid black, or to 4 different hatch patterns that use varying amounts of white and black. If you want to convert to solid, un-patterned black and white, you specify a value of 2/0. If you want to use hatch patterns, specify a value of 2 followed by a / and the number of patterns from 1 to 5. Acceptable values range from 2/0 to 2/5.

The following table indicates the effect produced by each hatch pattern conversion value:

<b>Value</b>	<b>Result</b>
2	(Defaults to 2/4). Uses black, white, and eight hatch patterns.
2/0	Uses black and white. No patterns.
2/1	Uses black, white, and one hatch pattern.
2/2	Uses black, white, and three hatch patterns.
2/3	Uses black, white, and five hatch patterns.
2/4	Uses black, white, and eight hatch patterns.
2/5	Uses black, white, and thirteen hatch patterns.

### To convert from color to black and white:

1. Load the image into RezSolution.  
If it is already loaded, make it the active document window.
2. Enter the a value (from 2/0 to 2/5) in the Colors apply data box.
3. Click the Apply button.  
The image is converted.

The image is not permanently changed until you save it with the changes. You can save the changes, experiment with additional changes, or undo the changes to return the graphic to its original state.

## Converting from One Color Palette to Another

RezSolution lets you convert images from one palette to another. The following color conversions are supported:

- 2        black and white (monochrome)
- 8        Windows 2.x basic color palette
- 16       Windows 3.0 standard (four plane graphic)
- 256     Standard and customized (eight plane graphic)

**Note:** RezSolution does not support 16 color custom palettes.

When you have a color graphic file that supports a different number of colors than your system, and you open that file in RezSolution it is automatically converted to the system number of colors. For example, if you are working on a 256 color system and open a 16 color graphic in RezSolution, the graphic is converted to 256 colors. Note that this change is not permanent until you save the file. Also, the file will not automatically contain more colors simply because you convert it. You must open a graphic editor, such as Paintbrush, and add color to it.

**Caution:** If you open and save a file that originally supported more colors than your system supports, that graphic will be converted so that it uses the lesser number of colors. For example, if you are working on a 16 color system and open and save a 256 color graphic, it will be converted to 16 colors. To avoid converting an open file, simply close it without saving changes.

## **File Header**

The color information about a specific file is stored in the file header. When the graphic file is opened in a paint program, the color palette receives data from the file header. For example, if the file uses up to 16 colors and the system also supports 16 colors, the palette appears with 16 colors. If the file uses 2 colors, and the system supports 16 colors, the palette appears with only 2 colors (black and white). The limit is the number of colors supported by your system.



## Understanding the Active Window Data Bar

The active window data bar displays the sizing and color values for an image in the active window within RezSolution. The active window is either the Clipboard Viewer or a document window.

### Width and Height areas

These areas show the width and height of the graphic in the active window.

### Colors area

If the graphic in the active window is monochrome, the Colors area shows the value 2.

If the graphic in the active window is color the Colors area shows the number of colors supported by the current system.

As an example, if you open a 256-color graphic on a 16-color system, the Colors value in the active window data bar is 16 because that is the number of colors supported by the system. Similarly, when an 8-color graphic is opened on a 16-color system, the Colors value is 16. In both cases the graphic is converted to a 16 color graphic.

**Caution:** When you open a graphic on a system that supports fewer colors, the quality of the image may be degraded. For example, if you open a 256-color graphic on a 16-color system, the graphic will only be displayed using 16 colors. DO NOT SAVE THE IMAGE and the file will remain in its original 256-color state. IF YOU SAVE THE IMAGE IT WILL BE PERMANENTLY CHANGED.

### X Res and Y Res areas

If the graphic in the active window is a .PCX file, these areas show the resolution of the system on which the graphic was originally created.

If the graphic in the active window is a .BMP or .RLE file, these areas show the resolution of the current system.

## Understanding the Apply Data Boxes

The apply data boxes are the white, lower row of boxes to the right of the Apply button. When you first run RezSolution, these boxes contain the system defaults. The Colors box contains the number of colors supported by the current system, the X Res and Y Res boxes describe the resolution of the current system, and the Zoom % is set to 100%. If there is an image on the Clipboard (in the Clipboard Viewer) the width and height of the image appear in the Width and Height boxes.

Use the apply data boxes to enter the values you want to apply to the image in the active window. Once you enter one or more new values in the apply data boxes and click the Apply button, the values in the grey, active window data bar are recalculated to reflect the change(s).

To undo the changes, click on the X button. To return the active window data bar to the system defaults, click the Defaults button.

## Applying Changes to an Image

Use RezSolution to apply changes to the size, color, and/or resolution of a graphic.

**Note:** Applying a change is different from saving changes to a file. Applied changes can be undone, saved changes are permanent.

There are two basic ways to apply changes to a graphic:

- In some situations, changes are applied to a file as soon as it is opened in RezSolution.
- In other situations, you must deliberately choose to apply changes to an image in either the Clipboard Viewer or the active window.

The color of an image is sometimes changed as soon as you open it in RezSolution. For example, if you open a 256-color image in RezSolution on a 16-color system, the graphic immediately appears in only 16-colors. The change is permanent only if you save the file. If you close the file without saving it, the file still uses 256 colors.

You can also use the [apply data boxes](#) to change an image in either the active document window or the Clipboard Viewer.

## Using the Apply Data Boxes

You can also use the apply data boxes to change the following attributes of an image in either the active document window or the Clipboard Viewer:

### Width and Height boxes

The width and height of an image are measured in pixels. Changing the width and/or height of an image can reduce or stretch the image horizontally and/or vertically to a new size. The width value can be changed by editing the value in the Width box, the height value can be changed by editing the value in the Height box, or both values can be automatically altered by changing the value in the Zoom % box.

### Colors

The value in the Colors box is the number of true (not mixed) colors available for each pixel. RezResolution can only change from the current number of system colors to 2 colors (black and white), or from 2 colors to the current number of system colors.

RezResolution supports image color conversion such as 256 to 16, 16 to 2, 8 to 16, etc. For example, if you are displaying your image on a 16 color system and the image was created and saved with 8 colors, the system must convert the image each time it is displayed.

### X Res and Y Res

By default, X Res is the horizontal value of the current screen resolution and Y Res is the vertical value of the current screen resolution. When you change the values these boxes, the Width and Height values in the active window data bar are automatically recalculated. RezResolution allows you to simulate any X and/or Y resolution. (To return this value to the system default, click on the Defaults button.)

### Zoom %

Zoom % is the percentage by which you want to increase or reduce the size of the image. When an image is opened the default zoom level is 100%.

When you want to enlarge an image, use a zoom percentage that is greater than 100%. For example, 200% doubles the size of the image. When you want to reduce the size of an image, use a zoom percentage that is less than 100%. For example, 50% reduces the image to one half its size.

When a new zoom percentage is applied, the width and height of the image are changed proportionately. That is, if you specify a zoom percentage of 200%, both the width and height are doubled.

## **Undoing Applied Changes**

Use the X button to undo changes applied with the Apply button. If the image being manipulated is in the Clipboard Viewer, it is returned to its original state. If the image is a file, it is returned to the condition that was current as of its last file save.

## **Displaying the Current System Defaults**

Press the Defaults button to return the system default values for Colors, X Res, Y Res, and Zoom %.

## Using the Clipboard Viewer

The Clipboard Viewer is a permanent feature within the workspace. It is a special window that lets you view and manipulate the contents of the Windows Clipboard. Typically, you place graphic images on the Clipboard by capturing a screen, the contents of a window, or some other region of the screen. You can also place items on the Clipboard through the Copy command from the Edit menu.

The Clipboard Viewer is updated each time a bitmap graphic image is sent to the Windows Clipboard. The Clipboard Viewer is always open, and cannot be closed.

**Note:** Only bitmap graphic images can be seen in the Clipboard Viewer.

You toggle on a feature so that every time you capture an image or copy an image to the Clipboard, RezSolution also places the image in a new document window. To do this, choose New Window On Clipboard Change from the Options menu.

## Using the Mouse Data

The Mouse Data area displays the current location of the mouse pointer and the size of a selected area. In order for the mouse to give current data it must be positioned over the Clipboard Viewer or a document window. When the mouse cursor is positioned over a graphic image, the pointer appears as a cross with a box in the lower right quadrant. When the mouse is in an invalid data position, it appears as an arrow.

The location of the mouse pointer is indicated by the XY coordinate values. This value is always relative to the upper left corner (0,0) of the document window in which the mouse pointer is currently positioned. A document window does not have to be made active to give mouse coordinate data.

The width and height of a selected area (in pixels) are indicated by the WH values.

## Loading Images into RezSolution

The first step toward manipulating an image in RezSolution is to bring the image either into the Clipboard Viewer or into a document window.

Three basic ways to load an image into the Clipboard Viewer are:

- Capturing any screen, window, or rectangular region that appears in Windows. (This means using the capture facilities that come with Windows and/or RezSolution.)
- Copying part of an image that appears in a RezSolution document window. (This means using the Copy command in RezSolution's Edit menu.)
- Copying or cutting an area from an image in another application that uses the Windows Clipboard. (This means using the Edit menu commands of another application to place an item on the Clipboard. Refer to the documentation for the other application for information on copying or cutting items to the Clipboard.)

Two common ways to load an image into a document window are:

- Opening an existing file in RezSolution.
- Opening a new document window and pasting an image into it.

## **Capturing a 256 Color Image**

When you use the Windows Clipboard to capture a 256 color image in Windows 3.0 a copy of the image is placed on the Clipboard. However, palette information is not captured. Therefore, if you save the image to a file, the palette information is not saved in the header file. When you reopen the file, the proper colors may not appear because the file does not contain the necessary color palette data. Solve this problem by running RezSolution when the screen is captured. Save the file using RezSolution and it saves the palette information as well.

## Capturing New Images

You can use RezSolution to capture any screen, window, or region of the screen in Windows. Once the image is captured, you can apply size or color changes to it and optionally save it to a file.

By default, when you capture an image it is placed on the Clipboard. It can therefore be viewed and manipulated in the [Clipboard Viewer](#). Each time you capture an image, it replaces the last image on the Clipboard. Optionally, you can choose New Window on Clipboard Change from the Options menu so that when an image is captured, it is placed on the Clipboard and placed in a new document window. This is helpful if you want to capture a number of images, load each into a document window, and manipulate them later.

## Capturing a Region

To capture a region, you must have the RezSolution window opened. Typically you run RezSolution, resize it, and move it out of the way so that it doesn't interfere with the region of the screen you want to capture.

By default, when you capture an image it is placed on the Clipboard. It can therefore be viewed and manipulated in the [Clipboard Viewer](#). Each time you capture an image, it replaces the last image on the Clipboard. Optionally, you can choose New Window on Clipboard Change from the Options menu so that when an image is captured, it is placed on the Clipboard and placed in a new document window.

### To capture a region:

1. Choose Capture Region from the Capture menu or press CTRL + R.

The cursor becomes a hand

2. Position the mouse pointer in the upper left corner of the region.
3. Press the mouse button and drag to the lower right corner of the region.

A box appears to indicate the selected area. To draw a perfect square, hold down the SHIFT key while you drag the mouse. If you are not satisfied with the selected area, click the right mouse button to cancel the region capture.

4. Release the mouse button.

The area is copied to the Windows Clipboard and is displayed in the Clipboard Viewer window.

Once an image is in the Clipboard Viewer you can apply changes to it and optionally save the image to a file.

## Capturing a Window

RezSolution does not have to be running to capture an application window. An application window is captured using a feature of Windows.

By default, when you capture an image it is placed on the Clipboard. It can therefore be viewed and manipulated in the Clipboard Viewer. Each time you capture an image, it replaces the last image on the Clipboard. Optionally if RezSolution is running when you capture a window, you can choose New Window on Clipboard Change from the Options menu so that when an image is captured, it is placed on the Clipboard and placed in a new document window.

### To capture a window:

1. Position the mouse pointer in the window to be captured.
2. Click the left mouse button to select the window.
- 3.. Press the ALT + PRINT SCREEN keys.

The active window is copied to the Windows Clipboard and is displayed in the Clipboard Viewer.

**Note:** When capturing application windows that use 256 colors, it is recommended that you run RezSolution, because RezSolution captures the color palette along with the image.

Once an image is in the Clipboard Viewer you can apply changes to it and optionally save the image to a file.

## Capturing the Entire Screen

RezSolution does not have to be running to capture an entire screen. An entire screen is captured using a feature of Windows.

By default, when you capture an image it is placed on the Clipboard. It can therefore be viewed and manipulated in the [Clipboard Viewer](#). Each time you capture an image, it replaces the last image on the Clipboard. Optionally, if RezSolution is running when you capture a screen, you can choose New Window on Clipboard Change from the Options menu so that when an image is captured, it is placed on the Clipboard and placed in a new document window.

### To capture a screen:

- Press PRINT SCREEN on the keyboard.

The screen is copied to the Windows Clipboard and is displayed in the Clipboard Viewer.

**Note:** When capturing screens that are using 256 colors, it is recommended that you run RezSolution, because RezSolution captures the color palette along with the image.

Once an image is in the Clipboard Viewer you can apply changes to it and optionally save the image to a file.

## Capturing Multiple Images

Multiple images can be captured and placed into windows without returning to RezSolution between each screen capture. This procedure can be used for capturing graphic images from a Windows application for developing software application tutorials or presentations.

### To capture multiple images:

1. Choose New Window on Clipboard Change from the Options menu.
2. Capture the images by following one of the techniques for capturing a region, a window, or an entire screen.

Each time you capture an image, it is pasted onto the Clipboard. Every time the Clipboard is modified, a new document window is created and the contents of the Clipboard Viewer are copied into the new window.

Once an image is loaded in a document window you can manipulate it, and optionally save it to a file.



## Hiding and Unhiding RezSolution

You may want to hide the RezSolution window when you capture a full screen. If you make RezSolution an icon, it remains on the screen. You may not want to see the icon on the captured image.

### To hide RezSolution's window:

- Choose Hide RezSolution from the Capture menu or press CTRL + D.  
RezSolution immediately displays a message reminding you of how to unhide RezSolution.  
The RezSolution window remains the active window until another window is selected.  
Press CTRL + R to activate the Capture Region Command, and select a region of the current screen, or use the PRINT SCREEN keys to capture the entire screen.

**Note:** The Capture Region Command is only active when RezSolution is the current selected window. If you hide RezSolution and click on another window to make it active, the CTRL + R (capture region) option is no longer available.

### To unhide RezSolution's window:

1. Press CTRL + ESC or double click on the Windows Desktop.  
The Task List dialog box is displayed.
2. Choose RezSolution
3. Select Switch To.  
The RezSolution window is restored

## Copying an Image to the Clipboard Viewer

You can copy images onto the Clipboard by using RezSolution's Copy command or by using the Edit menu commands of another application that is designed to place items on the Windows Clipboard. (Refer to documentation for the other application for information on copying or cutting items to the Clipboard.)

### **To copy an entire image to the Clipboard from a RezSolution document window:**

1. Click on the document window that contains the image you want to copy.

This makes it the active window.

2. Choose Select All from the Edit menu.

The entire graphic image is selected.

3. Choose Copy from the Edit menu.

The image is copied to the Clipboard.

Once the image is on the Clipboard, you can apply changes to it, and optionally, save it to a new file. The image in the original document window remains unchanged.

### **To copy a portion of an image from a RezSolution document window to the Clipboard:**

1. Click on a document window to make it the active window.
2. Position the mouse pointer in the upper left corner of the area to be copied.

The mouse pointer becomes a cross when positioned on a selectable area.

3. Press the left mouse button and drag down and to the right.

A box appears to indicate the selected area. To draw a perfect square, hold down the SHIFT key while you drag the mouse. If you are not satisfied with the selected area, click the right mouse button to cancel the select region option.

4. Release the mouse button when the area is selected.

Once the image is on the Clipboard, you can apply changes to it, and optionally, save it to a new file. The image in the original document window remains unchanged.

## Pasting an Image from the Clipboard

You can take an image from the Clipboard and paste it into a document window.

For example, when you capture an image from outside RezSolution it is automatically placed on the Clipboard. The captured image on the Clipboard appears in the Clipboard Viewer. You can apply changes to the image while it is in the Clipboard Viewer. However, you might want to paste the image into a document window so that it is not accidentally replaced if you capture or copy a new image to the Clipboard.

The document window where you paste an image can be a new, empty one that you open just for this purpose, or it can be an open document window that already contains an image.

**Warning:** If you paste an item from the Clipboard into a document window that already contains an image, the image is completely replaced by the pasted item.

To paste an image from the Clipboard:

1. Open a new document window or click in an open document window to make it the active window.
2. Choose Paste from the Edit menu.

The image on the Clipboard (in the Clipboard Viewer) is pasted into the active window. Any image previously in that window is replaced by the pasted item.

## Understanding Image Resolution

Resolution is the number of horizontal and vertical pixels, and the number of color values available for each pixel. The resolution of a graphic is commonly stated as the number of pixels across by the number of pixels down, and the number of available colors. For example, "640 pixels by 480 pixels, 256 colors", written 640 x 480 x 256.

Different computer systems are designed to display graphics of different resolution. For example, one system may be capable of displaying graphics that are 640 x 480, 16 colors, while another system may be capable of displaying graphics that are 1024 x 768, 256 colors. In general, the more pixels on the screen, the more well-defined and detailed an image can appear.

The resolution of a computer system is determined by its graphics adapter and monitor. Microsoft Windows supports several graphics adapters with varying resolutions.

Enhanced Graphics Adapter (EGA)	640 x 350 (16 color)
Video Graphics Array (VGA)	640 x 480 (16 colors)
Enhanced Video Graphics Array (EVGA)	800 x 600 (256 colors)
Super Video Graphics Array (SVGA)	1024 x 768 (256 colors)

**Note:** A low resolution driver is available for Windows 3.0 users. Contact your IconAuthor sales representative for more information.

When graphic images are saved to a bitmap file, the resolution of the graphic is saved in the file header data. When the graphic is displayed in an alternate screen resolution, the image appears distorted.

## Changing Resolution across Systems

You may need to change the resolution of graphics because you are moving them from one system to another. For example, if you take a graphic file that was created as a full screen image on a VGA 640 x 480 system and open it on an SVGA 1024 x 768 system, the image will no longer be full screen.

The process for changing resolution varies depending on the format of the file you are using. Files that use a .PCX file format are handled differently from files that use a .BMP or .RLE format.

### Changing .PCX File Resolution:

The resolution of your system is described by the values in the white X Res and Y Res apply data boxes. For example, if you are on a 640 x 480 system, the X Res is 640 and the Y Res is 480.

1. Open a .PCX file of a different resolution on your system.

The X Res and Y Res areas of the grey active window data bar describe the resolution of the system on which the graphic was created. For example, if the graphic was created on a 1024 x 768 system, the active window data bar will indicate that the X Res is 1024 and the Y Res is 768. (These values appear in the just above the values that describe your system resolution.)

The active window data bar also shows the width and height of the original graphic. The apply data boxes show the width and height values necessary for converting the graphic to the resolution of the current system.

2. Click on the Apply button.

The image size is automatically adjusted.

### Changing .BMP and .RLE File Resolution:

1. Before you open the graphic being converted, you must note the original resolution of the graphic.
2. As before, the X Res and Y Res values in the white apply data boxes initially describe the resolution of the current system. Replace these values with the resolution of the system originally used to create the graphic.
3. Open the graphic you want to convert.
4. Click on the Defaults button.
5. Click on the Apply button.

The image size is automatically adjusted.

## **Saving New Images**

**Warning:** Once you save a file, you cannot undo changes that you have applied.

You can save an image on the Clipboard to a new file or you can save an image in an untitled document window to a new file.

### **To save clipboard and new document window images:**

1. Click anywhere within the Clipboard Viewer window or the new document window to make it the active window.
2. Select Save As from the File menu to save the image to a new file.  
The Save As dialog box is displayed.
3. Enter a filename in the Filename text box.  
If necessary, use the Directories list box to change the path used to save your file.
4. Select a file format by clicking on the desired file extension.  
The default file format is .BMP (bitmap). If no extension is specified, the file will be saved as a .BMP file. When a file format is selected, the file extension is automatically entered into the Filename text box.
5. Click on OK to save the image, or select the Cancel button to cancel the Save As command and return to RezSolution.

## **Saving Changes to Existing Files**

**Warning:** Once you save a file, you cannot undo changes that you have applied.

Whenever you change an existing file, you must decide whether to save the image to the same file (Save command), or save the image to a new file (Save As command). When an existing image is saved to a new file, the contents of the original file remain the same as before any changes were made.

### **To save changed files to the same filename:**

1. Click anywhere within the document window containing the image you wish to save. The window becomes the active window.
2. Choose Save from the File menu.

The image is updated and saved to the existing filename specified in the document window title bar. The Save Command replaces the changed file with the original file.

**Hint:** To preserve the original file, make a working copy and edit the working copy. This procedure insures that you can always return back to the original file if the changed results are not what you expected.

### **To save and rename changed files:**

1. Click anywhere within the document window containing the image you wish to save. The window becomes the active window.
2. Select the Save As Command from the File menu.

The File Save As dialog box appears to prompt you for the filename of the graphic. Since the graphic has previously been saved, the current filename appears as the default filename. You can accept this filename (same as Save) or enter a new filename.

3. Edit or re-enter a new filename in the Filename text box.

A filename can be modified by either making a change to the existing filename using the keyboard, or by clicking on a new file extension radio button. When a new file format is selected, the extension of the file in the Filename text box is automatically updated.

4. Click on OK to save the image to the new file, or select the Cancel button to cancel the Save As Command and return to RezSolution.

The title bar of the document window is changed to reflect the new filename. The Save As... Command saves the file to the current directory.

**Note:** This method of saving a file preserves the original file.

## Automatically Saving Changes to Multiple Files

Use the Open,Apply,Save Command from the File menu to automatically open one or more files in one directory, apply the same changes to each file, and save each file. The first file is opened, changed, and saved, then the second, etc. This feature is useful, for example, if you want to convert 30 files to black and white, or increase the size of 3 files by 150%.

### To open, apply and save a file:

1. Use the keyboard to enter new values in one or more of the apply data boxes.  
For example, to increase the size of a group of files by 125%, enter 125 in the Zoom % box.
2. Select the Open,Apply,Save Command from the File menu.
3. Use the Directories list box to move to the directory that contains the file(s) you want to change.
4. Use the Files list box to select the file or files to be changed, or click on the Select All button to select all the files in the current directory.
5. Optionally, select the Confirm Save check box if you want to confirm the changes to each file before it is saved.
6. Optionally, choose Options >> if you want to specify a different file format.
7. Optionally, choose Info... if you want to view an Information dialog box that shows the current attributes of a selected graphic file.  
If several files are selected when you choose Info... an Information dialog box appears for the first file. When you choose OK to close that dialog box the information for the second file appears, and so on.
8. Choose OK to accept the contents of the Open,Apply,Save dialog box, or choose the Cancel button to cancel the Open,Apply,Save Command and return to RezSolution.

When you choose OK, the new attributes are applied to each file and each file is saved with its original filename (unless a new file format was selected). To cancel the Open,Apply,Save Command press the Esc Key.



## Working with Document Windows

A document window is another kind of window that you can open within the workspace. A document window is a window within the RezSolution workspace where you can display an image. For example, when you open a graphic file in RezSolution, the image is displayed in a document window. You can have as many document windows open as your system's memory will hold. The document window title bar contains the path and name of the file. If the image in a document window has not yet been named, the title bar is labeled "(Untitled)".

To show only the filename in the title bar of a document window, choose Show File Path from the Window menu. (This deselects the full pathname feature which is on by default.)

You can move, resize, minimize, and restore document windows. You can also close them. In order to apply changes to an image in a document window, that document window must be the active window. Click anywhere in a window to make it active.

In many ways, the Clipboard Viewer behaves similarly to a document window. For example, you can apply changes to an image in the Clipboard Viewer and save the image to a file. The basic difference between the Clipboard Viewer and a document window is that the contents of the Clipboard Viewer is replaced when an image is cut, copied, or captured. Also, unlike document windows, the Clipboard viewer cannot be closed.

## **Opening New Document Windows**

When you open a new document window it is empty and untitled. You can load an image into the window by pasting the Clipboard contents into it.

### **To open a new document window:**

- Choose New from the File menu.

A new document window is created. The contents of the window is blank and the title bar contains the text "(Untitled)".

## Opening Existing Graphic Files

When you open an existing graphic file in RezSolution it is automatically loaded into a document window. One or more files can be opened at a time. The RezSolution workspace can contain any number of opened windows.

### To open an existing graphic file:

1. Select Open... from the File menu
2. Move to the directory containing the graphic file(s) you want to open.
3. Select the file(s) you want to open.

To select all the files, click on the Select All button.

To select two or more files in sequence, click on the first filename, press and hold the SHIFT key, click on the last filename in the sequence, and release the SHIFT key.

To select two or more files out of sequence, click on the first filename, press and hold the CTRL key, click on each additional filename you want to select, and release the CTRL key.

## Closing Document Windows

You can close one or all document windows in the workspace. If an image in a document window contains unsaved changes, RezSolution will ask if you want to save the changes before closing.

### To save and close a document window:

- Double click on the Control-menu box of the window you want to close.  
If there are any changes to the selected window that have not been saved, you are prompted to save the changes.

### To close all the document windows:

- Select Close All from the Window menu.  
If there are any changes to the window(s) that have not been saved, you are prompted to save the changes.  
If you respond **Yes** to the save changes dialog box you are prompted with the File Save As dialog box.

**Warning:** When you save changes made to a graphic file, the file is permanently altered.

## **Deleting Graphic Files**

RezSolution lets you delete graphic files. Use this feature with caution because the deleted file is not just removed from RezSolution, it is deleted from your disk.

### **To delete a graphic file:**

1. Make sure the file you want to delete is open and in the active document window.
2. Choose Delete from the File menu.

A Dialog box appears with the directory path of the selected file, asking you to confirm that you want to delete the file.

3. Select Yes if you want to delete the selected file or No to return to the RezSolution window.

## **Printing Graphic Files**

RezSolution lets you print a graphic file if your printer is properly installed and selected. The appearance of the printed page varies depending on the current page setup. You can use the default settings for page setup, or you can use the Page Setup... command from the File menu to change the layout of the printed page.

### **To print a graphic file:**

1. Make sure the file you want to print is open and in the active document window.
2. Choose Print from the File menu.

A dialog box appears informing you that the print process has begun. Optionally, choose Cancel to cancel the Print Command.

## Changing the Page Setup

When you print a file, you can use the default margin and header/footer settings or you can use the Page Setup dialog box to customize the layout of the page.

### To open the Page Setup dialog box:

- Choose Page Setup... from the File menu.

### To reset margins:

1. Click in the appropriate box in the Margins area and enter a new value.
2. Choose OK.

### To setup headers and footers:

- Use the Header and Footer text boxes to enter text and/or any codes you want to appear at the top and bottom of each page.

For example, you can type the word "Date" followed by a space and &d in the Header text box. This generates text such as "Date 12/15/91" at the top of the printed page.

Use the following codes to generate and format information in the Header and Footer text boxes:

&d Generates the current date.

&p Generates page numbers.

&f Generates the current filename.

&l Justifies the text that follows at the left margin.

&r Justifies the text that follows at the right margin.

&c Centers the text that follows.

&t Generates the current time.

## **Quitting RezSolution**

To exit from RezSolution, choose Exit from the File menu.

If there are any unsaved changes to files in document window(s), you are prompted to save the changes.

The dialog box gives you the option to save the changes, not save the changes, or cancel back to your last working position within RezSolution.

If you respond Yes to the save changes dialog box a File Save As dialog box appears.

To exit without saving the changes, select No.
