Distribution and Restrictions

This package was developed by a member of the Association of Shareware Professionals. **Capital Gainz may only be distributed as a complete package, and ONLY THE EVALUATION VERSION may be distributed.** Modification of the executable in any way is strictly prohibited.

The two part installation archive is designed to fit on two 3.5" 1.44MB diskettes. **The installation archive provided may not be altered, renamed, or extracted and rearchived.** Such changes will cause incorrect or failed installations of Capital Gainz, resulting in angry customers and lost sales for us as well as you.

If you are an ASP approved vendor or BBS, then you are implicitly authorized to include Capital Gainz in your distribution library. All other vendors and BBS must receive explicit authorization to distribute Capital Gainz.

Capital Gainz may not be distributed via retail racks without explicit authorization from David Lee Cohen.

Explicit or implicit authorization to distribute Capital Gainz gives you permission to charge a reasonable distribution fee. - * To record a sale, specify how many shares to sell and the selling method: FIFO, LIFO, max gain, max loss, specific ID, average cost. The shares selected are displayed for confirmation or for a 'what if' scenario.
- * You can reinvest dividends, record splits and conversions, and enter bond discount/amortization.
- * Margin is supported by tying a cash account to a portfolio.
- * Calculate and compare a security's total return with your actual realized performance, which uses purchases, sales, and distributions to calculate the internal rate of return.
- * Update prices from a form, a file, or an online service. Updating a price will adjust the value of all portfolios holding that security.
- * Calculate and track historical portfolio values and performance.
- * Several levels of detail and summary reports are provided, and you can restrict the information by date range, security, portfolio, security type, or broker. Specific reports include portfolio allocation, expected income, and Schedules B and D from the tax forms.
- * Generate price and moving average graphs, allocation charts, cost/value charts, and other

graphs from your data.

- * Import prices retrieved from CompuServe, Prodigy, America Online, Telechart 2000, MetaStock, or a variety of Internet sites.

Unlike popular retail software that inappropriately forces the checkbook paradigm on users, Capital Gainz is designed solely to manage investments. Thus, investors find it to be more intuitive and 'cleaner' to use.
