Welcome to the RISS Solitaire Card Game Pak!

This is a shareware version of the RISS Solitaire Card Game Pak. If you enjoy these games and would like to play more unique and enthralling Solitaire-style games, we offer a RISS Solitaire 5-Pak as well as a value-bundled RISS Solitaire 8-Pak. Each of the solitaire games are very different from the others!

Please read on for details on the RISS Solitaire Card Games.

INSTALLATION

If you have not already run the SETUP.EXE program included with this product, please do so at this time. From within Windows, run the SETUP.EXE program which will automatically install the card games and add a program group and icons for each game.

WHAT GAMES ARE INCLUDED?

This shareware version of the RISS Solitaire Card Games collection contains two exciting card games: **King Albert Solitaire** and **Frog Solitaire**. While King Albert Solitaire looks somewhat like a traditional solitaire game, it's much trickier! Frog Solitaire probably doesn't look like anything you've ever played before!

Both card games come with Windows formatted help files with complete rules and instructions for each game. The help files even contain some helpful strategy hints for playing each game!

If you like these games and would like to continue playing them, or would like to order more card games, there are two registered versions available: the **RISS Solitaire 5-Pak** and the **RISS Solitaire 8-Pak**.

The RISS Solitaire 5-Pak contains everything in the shareware version, **plus 3 more** card games: **Golf Solitaire, Klondike Solitaire, and the Vanishing Cross Solitaire**.

The RISS Solitaire 8-Pak contains **everything in the 5-Pak, plus 3 MORE** card games: **Pyramid Solitaire, Canfield Solitaire, and Friday the 13th Solitaire**.

DEFINITION OF SHAREWARE

Shareware distribution gives users a chance to try software before buying it. If you try a Shareware program and continue using it, you are expected to register. Individual programs differ on details -- some request registration while others require it, some specify a maximum trial period. With registration, you get anything from the simple right to continue using the software to an updated program with printed manual.

Copyright laws apply to both Shareware and commercial software, and the copyright holder retains all rights, with a few specific exceptions as stated below. Shareware authors are accomplished programmers, just like commercial authors, and the programs are of comparable quality. (In both cases, there are good programs and bad ones!) The main difference is in the method of distribution. The author specifically grants the right to copy and distribute the software, either to all and sundry or to a specific group. For example, some authors require written permission before a commercial disk vendor may copy their Shareware.

Shareware is a distribution method, not a type of software. You should find software that suits your needs and pocketbook, whether it's commercial or Shareware. The Shareware system makes fitting your needs easier, because you can try before you buy. And because the overhead is low, prices are low also. Shareware has the ultimate money-back guarantee -- if you don't use the product, you don't pay for it.

REGISTRATION INFORMATION

This "shareware version" of this package is provided at no charge to the user for evaluation. Feel free to share it with your friends, but please do not give it away altered or as part of another system. The essence of "user-supported" software is to provide personal computer users with quality software without high prices, and yet to provide incentive for programmers to continue to develop new products. You are encouraged to pass the shareware version of the RISS Solitaire Card Games along to your friends for evaluation. Please encourage them to register their copy if they find that they can use it. Please refer to the VENDINFO.DIZ file for details on distributing this product. Please do not distribute the registered (non-shareware) version if you order it -- continue to distribute this shareware version.

If you find this package enjoyable and find that you are using the RISS Card Games and continue to use them after a reasonable trial period (60 days maximum), you must make a registration payment to Rhode Island Soft Systems, Inc. The registration fee will license one copy for use on any one computer at any one time, and ensure that you will receive a fully registered version of the software, which contains **EVEN MORE** card games!

BENEFITS OF REGISTRATION

What will registration yield? First and foremost, registered users are sent a disk containing the registered version of the software, with the additional games. Besides rightfully paying for a product that is being used, a user will additionally receive some very important benefits.

Upon receiving a registration, Rhode Island Soft Systems, Inc. will immediately return a written receipt, a letter of acknowledgment thanking the user for registering the software, literature on any special offers available at the time of registration, and the latest issue of RISS News, our company newsletter!

The user is immediately placed in our database of registered users from which we generate mailing lists for our newsletter which is used to announce upgrades to our products, or new products altogether. This is very important since many users have registered "old" versions of our software, not knowing that a newer version was available. We were able to provide them with a new version which they might not have received otherwise.

INTERNATIONAL (NON-U.S.) REGISTRATIONS

While it is true that we are based in the United States of America, we highly value our International Users! We've learned the "hard way", however we firmly believe that we are now in a much better position to serve our International customers more effectively.

For International Orders, the most convenient method of payment would probably be to charge the order to a Visa, MasterCard, AmEx, or Discover card. However, we do accept checks of course.

We request that, whenever possible, all checks or money orders be made out in U.S. currency and drawn on a U.S. bank. Often it is not possible to have a check drawn on a U.S. Bank, and we understand that.

Canadian customers can send checks written in U.S. Dollars from a U.S. Dollar account, drawn on a Canadian bank, without giving the matter any further thought. If you'd prefer to write a check in Canadian dollars, please apply the current exchange rate.

From other countries, however, we request that we be provided with a "Postal Money Order" from your National Post Office, or an American Express International Money Order. "U.S. Currency" or "U.S. Dollars" should be clearly marked on the check.

If none of the options above are possible, then we require an extra US\$10 check-cashing fee be added to the cost of registration. We apologize for this extra charge, however we are charged US\$10 just to cash an International Check. When writing a check or money order in non-U.S. currency, please make the necessary monetary conversions so that when we cash the check/money order we receive the full cost of the registration plus the equivalent of US\$10 to cover the check cashing fee. Users will be credited only for the amount received after conversion.
