PURPOSE:

OHM_LAW.EXE is an electrical calculation program which calculates resistance, current, and voltage based on Ohm's Law. It is one of a series of electrical and electronics calculations programs available for Microsoft Windows from Orion Software.

SYSTEM REQUIREMENTS:

Any hardware that will properly run Microsoft Windows Version 3.0 or later in Standard or Enhanced mode.

Microsoft Windows Version 3.0 or later.

VBRUN100.DLL (VBRUN.ZIP) dated May 10, 1991 or later.

INSTALLATION:

1. Copy the file OHM_LAW.EXE to your Windows directory.
2. Start Windows and the File Manager. Using the File Manager, find the OHM_LAW.EXE file and "drag" the icon into a Program Group and drop it.
3. Close File Manager and double-click on the OHM_LAW icon to run the program.
4. Remember to chose the "Save" option when exiting Windows after installing the program.

DEFINITION OF SHAREWARE: (Copied from ASP)
