File Menu

The File menu includes commands that enable you to manage files and directories, and to exit WinNAV.

For more information, select the File menu command name.

 $\underline{\text{Copy}}$ Copy files to another directory or disk. $\underline{\text{Delete}}$ Delete files or directories.

Exit Exit or close application or Windows session.

Information Display information on file or directory.Pack Access archive and

compressed file utilities. Print Files.

Rename Rename files or directories. Tools Access other utilities. Utilities Access

other tools.

Edit Menu

The Edit menu includes commands that enable you to edit text in the Quick View window, move text to and from the clipboard, to delete text, and to undo a previous editing operation.

For more information, select the Edit menu command name.

Clear Deletes text without moving it to the clipboard.

Copy Copies text to the clipboard.

Cut Deletes text and moves it to the clipboard.

Paste Moves text from the clipboard to the edit window.

Undo Cancels a previous operation.

Select All Select (mark) all text in window for edit operation.

Delete All Delete (remove) all text from window.

List Menu

The List menu includes commands that enable you to control the display of the list box windows, including performing local, branch and global explores, limiting or expanding file listings by name, type, date or size, refreshing the current list, and related operations.

View Menu

The View menu includes commands that enable you to access user defined external viewers or applications, or select an alternate internal viewer for the Quick View window.

Alternate internal viewers allow a file to be viewed in standard text mode or a seven-bit text mode (for files which use the eighth-bit for control characters, e.g., WordStar), to snoop for text in any type of file, or to view directories of popular archive or compressed file formats.

Action Menu

The Action menu includes commands that enable you to open or run a file or application, a DOS window, additional copies of WinNAV, or a user defined editor, to assign user defined function key combinations, and to access advanced Launch and Run dialog panels and file association and linking features.

User Menu

The User menu includes commands that enable you to display and run user defined applications, by selecting same from a popup menu. These selections are assigned, defined and modified through the New, Update and Remove options of the Action Run dialog panel.

Options Menu

The Options menu includes commands that enable you to configure the alternate settings of the list and view windows and application's display.

Window Menu

The Window menu includes commands that enable you to switch active windows, to rearrange the window layout and to zoom (maximize) or minimize a window.

Help Menu

The Help menu includes commands that enable you to access various features of WinNAV's help system, providing on-line help on the features and capabilities of the application.

Note:

This help system has not been fully implemented in this release; however, registered users will be provided with updated help files as they are completed and released.

System Menu

The System menu includes commands that enable you to minimize, maximize, move, size and restore the application on the Windows desktop, to arrange icons and tile non-iconized windows, and to launch various system related applications, including control panel, setup, program, file and print managers and system editors.

In addition it provides access to WinNAV's advanced Launch dialog panel, even when WinNAV is in an icon mode.

It also provides three methods for exiting both WinNAV and Windows.

Close Exits or closes WinNAV or ends the Windows' session.

Ends the current Windows session in the standard fashion.

allowing all running applications to prompt for necessary

user input such as whether to save or close a file.

Kills the current Windows session, by immediately

terminating all active tasks and windows -- including any open DOS windows or applications. Running applications will not prompt for user input prior to termination, therefore, care should be exercised in using this advanced feature.

All System commands may be accessed even when WinNAV is minimized, by clicking on its icon.

File Exit Command

This command exits or closes the application. In addition, if WinNAV is installed as the shell application, closing it will also terminate the current Windows' session.

This command is identical to the Close command on the System popup menu.

The System commands End and Kill may also be used to terminate WinNAV <u>and</u> the current Windows session.

File Copy Command

This command invokes the Copy dialog panel.

File Delete Command

This command invokes the Delete dialog panel.

PAGE UP or PAGE DOWN	Moves up or down in a field or list, one screen at a time.
