Welcome to Mac Domain


Robert Accettura's Mac Domain is a simple Application to help you find out what country a web site or an email is from. It compares the top-level domain of a web site or email address to an internal database of **well over 250 registered top-level domain names**. It will then tell you what country that address is from. It is very useful for when you have an email and want to know what country it was sent from.


1. When you launch Mac Domain you will see a splash screen. Click "Start"



2. Enter the top-level domain that you wish to look-up. Then select the "OK" Button

3. If it is a valid top-level domain, Mac Domain will then show you where it is from.



4. That's it. If you wish to look-up another top-level domain, simply re-launch the Mac Domain Application and repeat the steps above.

Costs

Mac Domain is \$15 shareware. If you decide to keep it, please register. Support from users like you is what funds future development for shareware such as this. You can pay on the Internet at http://accettura.com/buy, or with the Register program that accompanies Mac Domain. Enter your name, your email address, and the number of single user licenses you desire for each program you wish to purchase. Save or Copy or Print the data from the Register program and send the data and payment to Kagi. More specifics on the Register program to follow. Kagi handles my payment processing.

If paying with Credit Card, you can email or fax the data to Kagi. Their email address is sales@kagi.com and their fax number is +1 510 652-6589. You can either Copy the data from Register and paste into the body of an email message or you can Save the data to a file and you can attach that file to an email message. There is no need to compress the data file, it's already pretty small. If you have a fax modem, just Print the data to the Kagi fax number.

Payments sent via email are processed within 3 to 4 days. You will receive an email acknowledgement when it is processed. Payments sent via fax take up to 10 days

and if you provide a correct internet email address you will receive an email acknowledgement.

If you are paying with Cash or USD Check you should print the data using the Register application and send it to the address shown on the form, which is:

You can pay with a wide variety of cash from different countries but at present if you pay via check, it must be a check drawn in US Dollars. Kagi cannot accept checks in other currencies, the conversion rate for non-USD checks is around USD 15 per check and that is just not practical.

If you have a purchasing department, you can enter all the data into the Register program and then select Invoice as your payment method. Print three copies of the form and send it to your accounts payable people. You might want to highlight the line that mentions that they must include a copy of the form with their payment. Kagi can not invoice your company, you need to act on my behalf and generate the invoice and handle all the paperwork on your end.

Please do not fax or email payment forms that indicate Cash, Check or Invoice as the payment method. As far as we know, there is still no technology to transfer physical objects via fax or email and without the payment, the form cannot be processed.

Payments send via postal mail take time to reach Kagi and then up to 10 days for processing. Again, if you include a correct email address, you will hear from Kagi when the form is processed.

If you do not have an email address, please enter your complete postal address and please remember, we do not know what country you live in so please enter that into the postal address also.

Mac Domain has no "cripples" therefore it does not require a registration number. You will receive a confirmation via email after your registration has been processed. Please do not ask for a Registration number, because none are needed.
