

[Personal Log](#) is shareware. It may be distributed freely in its UNREGISTERED form as long as this document is included. In no way shall unregistered copies be sold at any price. Unregistered copies may be used by a user for up to 14 days before the user is obligated to pay the registration fee. This package ([Personal Log](#) and this document) may be included in the “pay for the media” shareware distribution methods (such as, but not limited to, CD-ROM archives) as long as Michael F. Kamprath, author of [Personal Log](#), is notified of such distribution and the buyer of the archive understands that the purchase does not include the purchase [Personal Log](#). Registered copies are the private property of the people who have paid for them, and they may not be distributed in any way. A single-user license allows the license holder to install [Personal Log](#) on one desktop Macintosh and one Power Book Macintosh as long as [Personal Log](#) will be used solely by the license holder. Reselling private copies is limited to single licensed copies and may not be sold for more than the shareware fee. Please notify Michael F. Kamprath when a license has been transferred so that a new password may be issued.

The site license rate is \$200 for a 10 copy license, and \$750 for an unlimited site license. The unlimited site license allows the holder to install [Personal Log](#) on all computers within a radius of 25 miles owned by the holder of the site license.

Please send payments in the form of a check or money order made payable to Michael F. Kamprath. If you are outside the United States, please make sure, before sending your payment, that your check or money order is cashable at a U.S. bank for the proper amount. If you cannot send a check cashable in the U.S., please send U.S. currency. (I do not recommend this.) If you work for a university or company which requires that a purchase order be sent, I will accept them as long as a formal purchase order form accompanies the order, along with a listed business phone number that can be verified. If you can fanagle it, however, I ask that you try to get your company to send me the money up front. Purchase orders are a pain.

If you are a resident of Australia, I suggest you contact the Australian Shareware Payment Association. Apparently, they utilize an American checking account, which will help keep your costs down in sending a US-cashable money order. You may contact them by telephone at 61-3-826-9839 or by mail at 6 Oxford Street, South Yarra, VIC 3141, Australia. Please remember, you must still send the additional US\$5 for overseas shipping. I am in no way associated with the Australian Shareware Payment Association —I am only passing along information passed on to me by previous registered users of [Personal Log](#).

If you have an account on CompuServe, you can register online. GO SWREG and follow instructions. [Personal Log](#)'s CompuServe registration ID is 6224. Please note, this is probably the best way to pay for people outside of the US. CompuServe handles the money exchange.

If you are already a registered user of [Personal Log v1.x](#), you can upgrade to [v2.0](#) for only \$10.

Registered owners of [Personal Log](#) are entitled to discounted upgrades of future versions. At no time shall the upgrade price be more than the difference between the price you paid for the your version and the price I am asking for the new version, although I may ask for additional funds to cover the cost of the disk and shipping.
