- 68020, 68030, 68040, or PowerPC microprocessor required for QuickTime™, PowerTalk™, and QuickDraw GX
- Minimum 8MB of RAM required for installation of full System 7.5 suite (16MB on Power Macintosh models)
- 4MB of RAM permits installation of all features except PowerTalk and QuickDraw GX (8MB on Power Macintosh models)
- Hard disk with up to 25MB of available space (depending on your system and configuration) to install System 7.5
