

**Instant Interactive
Software License Agreement for Instant Interactive Drills
Single Use License**

1. General. The software, documentation and any fonts accompanying this License whether on disk, in read only memory, on any other media or in any other form (collectively the "Instant Interactive Software") are licensed, not sold, to you by Instant Interactive ("Instant Interactive") for use only under the terms of this License, and Instant Interactive reserves all rights not expressly granted to you. The rights granted herein are limited to Instant Interactive's intellectual property rights in the Instant Interactive Software and do not include any other patents or intellectual property rights. You own the media on which the Instant Interactive Software is recorded but Instant Interactive retains ownership of the Instant Interactive Software itself.

2. Permitted License Uses and Restrictions. This License allows you to install and use one copy of the Instant Interactive Software on a single computer at a time.
