Executive Experience: Twenty years of managerial experience in data processing, designing creative concepts in three generations of EDP and managing departments of up to three hundred specialists and clerks. This experience included service with the following corporations:

APEXAL, Columbus, Ohio (April 1987-February 1989). **Marketing director.** Directed the work of 200 persons. One-third of this staff were professional specialists in research and advertising production. Reported directly to Mr. Gerald McCaffrey, then president of Apexal. Participated in top-level staff conferences. Invited to become manager of EDP Operations and assistant director of Marketing when Apexal absorbed by Luminale, but preferred to remain in Ohio, where I opened successful EDP consulting firm.

GRIFFIELD CHEMICAL COMPANY, Columbus Plant, Columbus, Ohio (January 1981-April 1987). **Manager, Records Division.** Participated in the design of this division when all corporate records centralized at Ohio Plant; worked with management consulting firm of Rennes, Campbell, and Dundee in basic systems study and design; recruited operating cadre, and managed this important division, budgeted at one million annually, for seven years; directed work of 300 persons. Value of my service to Griffield attested by fact that Griffield is one of my consulting clients at present. Left Griffield to become marketing director of Apexal.
