While Sound Collections #1 and #2 offered an extensive starting point for all the most important styles of popular and club-based music, Sound Collection #3 presents 7,500 absolutely brand new samples, including a special section dedicated to House. More than 2,500 samples and sounds from the 5 most important House styles can be found here: Deep House, Vocal House, Progressive House, Disco House and French House, each with its own typical and definitive collection of sounds. Of course all samples are 100% compatible – with each other and the samples of both Collections #1 and #2. Also completely eJay compatible are the sounds from the styles Big Beat (grooving breakbeats and guitar tunes), Techno (pure Detroit sound), Dance (from Club-Dance to Trance), Hip Hop (with dusty flows and edgy scratches), Trip Hop (a great supplement to the Hip Hop sounds), Drum & Bass (pitched, breaked and as always: fast!), Ambient (the athmo's for all D&B Loops) and Reggae (Live Drums, Live Bass, Live Guitar and a real Jamaican voice).

All samples in this exclusive, hand picked sound archive have been created by top international producers and are compatible with all music programs. All Sounds are in High Quality standard WAVE Format (16Bit/44.1 kHz) and with the help of the included eJay Soundbrowser 1.5, handling the collection could not be easier: searching, previewing, selecting and adjusting tempo.

To install EJAY SOUND BROWSER 2.0 place CD 9 in the CD-ROM drive and start the setup.exe. After a moment the installation menu will appear. From here you can install the program.



You can specify the installation path for the program. The display next to the installation path tells you how much free disk space is available on the selected drive.

Click on the INSTALL button to start the installation. You can cancel the process any time with the CANCEL button.

To be able to use the samples most effectively, we recommend that you free up as much hard disk space as possible before trying to install them. 100 samples require on average 40 MB disk space

## SOUND BROWSER 2.0

EJAY SOUND BROWSER 2.0 makes it possible to quickly and easily access the samples in eJay Sound Collections #1 to #5 (CDs 1 to 20) as well as all other samples on your hard disk. You can play up to four samples simultaneously, alter the playback speed and pitch of each, and even save them together in a WAV file.



eJay SOUND BROWSER 2.0 is divided into three zones. In the top left field you can search for samples on a CD or the hard disk. The bottom left field contains the destination folders into which the samples can be copied. Samples can be played back on the four tracks in the right hand field

### Searching for samples

There are two search methods available to you in eJay SOUND BROWSER 2.0. These can be activated by clicking on the appropriate icon.

If SEARCH SOUND COLLECTIONS is activated only the samples in the SOUND COLLECTION will be shown. The advantage of this search method is that you can search according to various criteria: style, instrument, tempo or key. The folders in the left window are accordingly structured.

If SEARCH HARD DISK is activated, the directory structure of your hard disk will be displayed and you can access all WAV files.

### **Listening to Samples**

You can listen to samples by double clicking on them with your mouse or, if the AUTOPLAY function is activated, by a single click. You don't have to first drag and drop the samples onto the tracks.

### **Saving Samples to a Destination Folder**

Drag and drop the samples you want to save into the destination folder of your choice. You can choose between several folders; the active folder is highlighted. By clicking on the BROWSE [...] button or double clicking on the current name of a particular destination folder, you can select up to five of your favourite destination folders for saving your samples.

### **Saving Formats**

Samples can be saved as WAV or as PXD files. The PXD format is a high-quality streaming format that is used in all eJay MUSIC CREATION products (Dance eJay series, Techno eJay series, Hip Hop eJay series, Street Style eJay, 360° Xtreme, House eJay). If you want to use the samples in one of these products, then it is worth converting them – PXD files are only one quarter of their original size in WAV format. Please note that during this process a stereo WAV file will be converted into two mono files. These are identified by the ending (L) or (R).

### **The Tracks**

The 4-track mixer allows you to check and modify the harmonic and rhythmic interplay of the samples. Samples from either the SEARCH or DESTINATION windows can be moved onto the tracks of the mixer using drag and drop. Please note that only one sample can be dragged onto each track.

Click on the PLAY button at the bottom of the screen to play all samples simultaneously. If you activate the LOOP button, the samples will be played back continuously until you click the STOP button. The SOLO and MUTE buttons allow you to blend out tracks or to listen to one track only.

If samples are in a different tempo, or if they are not full, half or quarter bars in length, they will be out of sync when played back simultaneously. Samples that have a common tempo and harmony will automatically sound good when played back simultaneously. You don't need to make any modifications before using them together.

The pitch, speed and volume of samples positioned on the tracks can be altered individually. To do so, either use the arrows directly beneath the relevant TEMPO and TUNE section or simply enter new values here directly. The direct entry method allows for two decimal places, meaning that fine-tuning is no problem. To compare the samples again you can deactivate TEMPO and TUNE by clicking the ON icon so it becomes deselected – the settings will, however, remain stored."

The sample volume can be modified using the vertical VOLUME FADER.

### **Saving Samples from the Tracks**

To save the samples including your modifications, click on the disk icon of the appropriate track. If you

want to save the samples together as a stereo WAVE file, click on the large disk icon at the very bottom right of the mixer window.

## THE SAMPLES

Each sample has its own name which describes the Sound's Instrument, Style, Tempo and Key in addition to which Sound Collection it belongs to, in the following case # 3.  
This is what it looks like: Instrument001\_Style\_BPM\_Key\_SC2

Got it? Here are two examples to show you more clearly:

The sample "DRUMLOOP030\_VOCAL\_125\_X\_SC3" is the Drumloop sample no.30, from the Vocal House section, which has a BPM of 125, no key, and is from Sound Collection #3.

Same thing with "VOICEBOY003\_RGGAE\_90\_A\_SC3". VOICEBOY is short for Male Voice, sample no.3, from the Reggae section, with a BPM of 90 and a key of A minor again from Sound Collection #3.
