What Is Shareware?

Shareware distribution gives users a chance to try software before buying it. If you try a Shareware program and continue using it, you are expected to register. Individual programs differ on details. Some request registration while others require it, some specify a maximum trial period. With registration, you get anything from the simple right to continue using the software to an updated program with printed manual.

Copyright laws apply to both Shareware and commercial software, and the copyright holder retains all rights, with a few specific exceptions as stated below. Shareware authors are accomplished programmers, just like commercial authors, and the programs are of comparable quality. (In both cases, there are good programs and bad ones!) The main difference is in the method of distribution. The author specifically grants the right to copy and distribute the software, either to all and sundry or to a specific group. For example, some authors require written permission before a commercial disk vendor may copy their Shareware.

Shareware is a distribution method, not a type of software. You should find software that suits your needs and pocket, whether it's commercial or Shareware. The Shareware system makes fitting your needs easier, because you can try before you buy. And because the overhead is low, prices are low also. Shareware has the ultimate money-back guarantee - if you don't use the product, you don't pay for it.

Terms And Conditions

Legal Eagle is a "Shareware program" and is provided at no charge to the user for evaluation. Feel free to share it with your friends, but please do not give it away altered or as part of another system. The essence of "user-supported" software is to provide personal computer users with quality software without high prices, and yet to provide incentive for programmers to continue to develop new products. If you find this program useful and find that you are using Legal Eagle and continue to use Legal Eagle after a reasonable trial period, you must make a registration payment of \$39.95 to Eagle Software. The \$39.95 registration fee will license one copy for use on any one computer at any one time. You must treat this software just like a book. An example is that this software may be used by any number of people and may be freely moved from one computer location to another, so long as there is no possibility of it being used at one location while it's being used at another. Just as a book cannot be read by two different persons at the same time.

Commercial users of Legal Eagle must register and pay for their copies of Legal Eagle within 30 days of first use or their license is withdrawn. Site License arrangements may be made by contacting Eagle Software.

You are encouraged to pass a copy of Legal Eagle along to your friends for evaluation. Please encourage them to register their copy if they find that they can use it. All registered users will receive a copy of the latest version of Legal Eagle.

Installation

Installation is a very straightforward process. All you need to do is insert the disk on which Legal Eagle is located into the drive, select that drive as the current drive by typing "A:"

or "B:" (depending on the drive in which the disk is inserted) at the DOS prompt. Now type **INSTALL** and follow the instructions on the screen. Legal Eagle Must Be Installed on the same drive as Windows in a directory Named **WINEAGLE** If you change to a drive Other then the one Windows is installed on you must include Wineagle in your Path statement in your **AUTOEXEC.BAT** File.

The install Program will run setup and bring up windows if You have changed the drive you are installing to form C to D you must tell **Setup** when it prompts you for Destination Drive.

Controls

At The Top of the screen are the menu choices **Loans, Loans2**, Ect Click the Mouse on one to bring up a list of forms , Select the form you wish to work with and click on it. Once the form is on the screen you can print it out or fill it out, to save the form you have changed you must rename it with the **save as** feature in the **Files menu**. As always all Windows Commands work with Legal Eagle.

The **Buttons** on the Right Of The Screen call up windows programs right from Legal Eagle. The **Dictionary Button** helps you to Define Legal terms you may not understand. the Help Button calls up This file. **Click on the Flag** and a FYI window Will Appear (FOR YOUR INFORMATION) with text files of Intrest. When your Done Just close Legal Eagle in the Box at the top left of the screen.
