## **INTRODUCTION**

Address Book for Windows is an application that you can use to create and maintain a database of names, addresses, and phone numbers. While the Cardfile included with Windows 3.0 has this capability, Address Book is a more specialized program, providing you with several more options to make phone list management more efficient. Address Book for Windows also includes several easy to use accessories including a temporary notepad, a memo writer, and a search option to create custom phone lists from a master file. You have several print options to give you more flexibility in choosing the type of phone listing you desire.

Address Book for Windows was written in Visual Basic. Since this environment requires Standard or 386 Enhanced mode, you must ensure you are in either of those operating modes before attempting to run the program. Additionally, this program was designed to be used on SVGA displays (800x600 resolution or higher). Using this program on a standard 640x480 VGA screen will have unpredictable results and should not be attempted. If you desire a copy of this program that is VGA compatible, please contact us at once and we will produce one for you in short order.

With such restrictive limitations, you may ask "Why use Visual Basic at all?" For starters, the limitations are by our own design. We wish to expend our time in a productive manner and will attempt to do so by targeting certain user types with specific programs. If there is feedback indicating preferences for other design options such as the previously mentioned graphics capability, we can easily accommodate these requests. Another reason to develop and exploit Visual Basic is for economy reasons. Due to the low cost and high support of Visual Basic, we can provide quality applications for an extremely reasonable cost. This fact coupled with the modular nature of Visual Basic will allow us to provide custom versions of our products to any user who requests it. We can provide these modified versions in a minimum amount of time to help get you going again.

# Getting Started

## **INSTALLING THE ADDRESS BOOK**

There are no special requirements or utilities required to install the program. Installation involves the same simple process required to install any program in your Windows environment. You should insure that the file VBRUN100.DLL is included in the same directory as your program or located within the specifications of your Path statement. Let's get started now.

1. Select the Program Group where you wish to place the Address Book in.
2. Select **NEW** from the File Menu in the Program Manager.
3. Select **Program Item** from the dialog box that appears and click OK.
4. Enter a description (ex Address Book) in the top text box.
5. In the next box, enter the pathname for the file and press the OK button.

The program's icon should now appear in the Program Group that you had selected. You also have the option of using the Windows Setup utility to install the program, however using this method takes considerably longer to complete the installation process. Once this process is complete, the Address Book will be ready to run. As a side note, there is only one icon included with this file. If you decide to change it, you must follow the directions in the Windows manual for using icon libraries.

## **BEGINNING TO USE THE ADDRESS BOOK**

Starting the Address Book is a relatively simple matter. The program does not accept command line parameters at this time and is not associated with any specific data file extension. To get started;

1. Double-Click on the Address Book icon while in the program manager
2. You may also select **RUN** from the File menu and enter the filename and/or pathname

Once you have done this the file will load and in a few seconds you will see the main display screen. During the loading process, Address Book creates several temporary files for it's own use. While the program is running, either as the active Window or in the background, you should **NEVER** delete any of these temporary files. You can recognize them by the ~TMP or ~PST prefix. Should you encounter a UAE or any other type of fatal error that causes the program to terminate, you may then go and delete these files prior to running the Address Book for a second time. Under normal circumstances, Address Book deletes these files when they are no longer needed. If you are running the program for the first time, there may not be a file called sercomm.cfg in your set. The Address Book will automatically create this file for you and advise you that the modem configuration needs to be redone.

At this point you should have the Address Book displayed and ready to begin working with telephone lists. The next section will cover some of the basic commands necessary to become proficient with it. Included is a sample file that will be referred to several times to highlight specific functions and options you have available.

# Using Address Book Files

## **OPENING A DATA FILE**

Included with this package is a sample data file called **sample.abk** and we will be using this file as an example. You may load up this file while going through this section and experiment with the commands we will be covering. The steps to load a data file are similar to all other Windows applications and you are probably already familiar with them. We will cover the steps anyways for those who aren't.

1. Select **OPEN** from the File menu along the top of the Address Book. A standard Open File dialog box will appear. Note the wildcard pattern in the filename box.
2. In the file list box, you should see the sample.abk file, click on this file and press **OK**. The selected data file should now begin loading.
3. Once the sample data file is loaded, you will see entries in the directory index list box on the lower portion of the screen. This is the index into the data file and provides overall control for the file system.

## **CREATING A NEW DATA FILE**

The Address Book initially works with temporary files and renames them upon saving or exiting the program. From a programming point of view, this allows for easier maintenance of the individual records. Whenever Address Book is started, it automatically creates a temporary file and sets its internal pointers to the first record. This is the same procedure that occurs whenever you select to create a new file. You should observe our previous warning concerning the deletion of these temporary files while the program is running. Doing so will corrupt any data you have stored. The steps to create a new file are quite simple.

1. Select **NEW** from the File menu on the top of the screen. You should now be ready to begin entering the data for your new file.

During this process, you may be prompted to store a record or save a file if that has not been accomplished prior to selecting the New option. These actions will not interfere with starting a new file.

## **SAVING A DATA FILE**

You are presented with two options to save your files, the Save and the Save As commands. The difference between the two is mainly the Save As option allows you to rename the file you are currently working with. During the course of file activity, records are duplicated, deleted, and overwritten many times. Program control is maintained through a system of pointers and indexes. What you can and will end up with is a data file size much larger than the program pointers indicate. The Address Book has built in maintenance routines which eliminate the duplicated records tacked on to the end of a data file. These routines are utilized throughout the session but also are called by selecting the Save option. This updates your current data file with no other intervention required. However, if you have created a new file and have not saved it yet using the Save As option, selecting Save will also prompt you for a permanent filename to use through a standard Windows Save File dialog box. This dialog box defaults to the current filename if working with a permanent data file. There may be instances where the full pathname is specified as a save filename, this is normal and will be truncated down to the filename portion by pressing the OK button.

1. Select **SAVE** or **SAVE AS** from the File menu.
2. When the dialog box appears, enter the desired filename into the text area.
3. Click OK when ready to proceed with the save.

To protect the database integrity from destruction due to inadvertant use of illegal filenames, a default extension of ABK is used on all filenames. Even if you specify a different extension when activating the save command, that extension will be removed and the proper one put in it's place. This will help ensure continuity with the search and print functions amd prevent any loss of data during these operations.

## **PRINTING A DATA FILE**

The Address Book's print options allow you some flexibility on how you want your output to appear. While the layout of the page is pretty much rigid, you do have the option on which fields to print, include the record index, add a blank page at the end, and to print an index listing which is referenced by page number to all the indexes in the file. Also, you may select Last Search file print, single data file print, and multiple data file printing. You can include a header and footer block, each 30 characters in length. To get started, we'll cover each of the file print options and the steps necessary to accomplish them.

### *Last Search File Print*

1. To print the Last Search file, first select **PRINT** from the file menu. Choose **LAST SEARCH** from the Select File option frame. There are no other options you can select for this item so click **PRINT** and the file should begin printing or should be sent to the Print Manager depending on your driver is configured

### *Single Data File Print*

With this option you can select a data file from any location to print. You will notice the print window has file controls that are almost identical to that of the open file selection box. This is to allow you to choose from a variety of sources. You should be aware of the fact that if you select files from a floppy drive, even after you add the name to the queue the disk must remain in the drive. During the printing process, the data file is read and you will generate a potentially fatal error if you have removed the disk. To begin, follow the steps below.

1. Select the directory list box to your desired directory. Any Address Book files in the directory will show up in the file list box.

2. To select a file for printing, click on the filename to highlight it. Then click the **ADD FILENAME TO QUEUE** button to place the file in the file queue. You can also double-click on the filename to add it to the queue.

3. Select **SINGLE DATA FILE** from the Select File Option frame. If you have more than one file in the file queue, you can highlight the filename in the queue to specify that singe file. Otherwise the first name in the list will be the file that's printed.

4. Select the desired fields that you wish to print from the Select Fields frame. If you plan on creating an index table, you must include the index in your selection from the frame.

5. Click the **ADD BLANK PAGE** checkbox if you want a blank page added at the end. These are useful for annotating changes before you have a chance to update your database.

6. Click **INCLUDE INDEX TABLE** if you want one printed at the end. For this option to work, you must have the Index field selected to print. If not you will get a message box advising you of this. When you exit the message box, the Index field will automatically be selected for you.

7. You can enter a header string in the header block. You are limited to 30 characters for the header string.

8. You can also enter a footer string using the same 30 character limit as the header.

### *Multiple Data File Print*

With this option, you can place up to 10 data files in the file queue and have them printed out in the order

that they were added. The file queue may be changed prior to beginning the printing by selecting a file and clicking the **REMOVE FILE FROM QUEUE** button. With this option, you will not be prompted for a title to place on the title page. Instead there will be a generic "Address Book" title. The procedure for selecting options is identical to the steps for printing a single data file and should be followed once the queue is set. Again remember that if a file is selected from a floppy disk, that disk must remain in the drive for it to be read and the program to function properly.



# Using Address Book Records

## **ADDING A NEW RECORD TO THE FILE**

Adding a record to the database is a fairly simple procedure. To begin, you should have the address book loaded and ready to go. The procedure on adding a record to a new file or to a previously opened one is the same. Simply click on the **ADD NAME** button. An input box will appear asking you to type in an index for the record. This index is very important to the operation of the file. The index determines where in the file the record will be stored at. Also, all other functions affecting the file and any records use this index for access. You should give some thought on what you want your index to be for various records. For individual names, the most common would be the last name of the individual. For business names and numbers, you may want to use an index by a category determined for example by the type of service the business performs. What ever you decide to enter, this index will be stored alphabetically in the index list directory towards the bottom of the screen. From there you can tab through to the individual text boxes and enter the necessary information. You should note that the text boxes will not accept any input until you have completed the index entry step. Let's review the steps now in entering a new record.

1. Click the **ADD NAME** button
2. Enter your desired index into the input box that appears.
3. You should see the index appear in the directory index and index search boxes.
4. You can now enter a name in the **NAME** text box. Use the mouse or tab button to advance to the address box
5. Enter the address in the **ADDRESS** text box. When done, advance to the City/State box.
6. Enter the city and state in the **CITY/STATE** text box. Again advance to the next box.
7. Enter a phone number in the **TELEPHONE** text box. If you plan on using a modem to autodial a selected phone number, there is a format you should follow. For local area phone numbers, you can enter the number as a 7 digit number, ex. 734-4288. If the number is a long distance number, you should use the following format, 1 - ### - #### or as an example, 1-402-734-4288. If you do not plan on using a modem, you can enter the number in any style you desire.
8. When you have finished entering all the data, click the **STORE NAME** button to place the record into the file.

The Address Book checks each record to see that it was stored before moving to a different function. It advises you if the record was not stored and gives you the option of storing it before moving on. For example, if you are entering several numbers, you can click Add Name instead of Store Name. You will be prompted to store or cancel the record. Click on your desired response and the index input box will then appear as you start the entry process over again.

## **DELETING A RECORD FROM THE FILE**

To delete a record from the file, you should have the targeted record displayed and it's index highlighted. These two items must match or the deletion will not take place. You will be advised of the discrepancy and the Address Book will reset the display to the highlighted index on the assumption that the record you wish to remove is the highlighted index. The steps are as follows.

1. Select and display the record you wish to delete.
2. Click on the **DELETE NAME** button.
3. The text boxes will clear and the index will be removed from the file.

Use caution during this step. There are no confirmation warnings that a record is about to be deleted. Because it is a two step process to delete a file, inadvertant deletes should not be a problem. There is

however no way to recover a record once it's gone so do be careful.

### **VIEWING A RECORD**

The process of viewing a record accomplishes several things. First of course the actual record is displayed. Secondly the program sets internal pointers to indicate which index is selected and which record is displayed. This keeps the file system in synch with user commands. The process of viewing a record is then the first step in several other command procedures such as deleting a name and storing a name after an edit operation. Also you must complete the steps to view a record to use the autodial function. Viewing a record is quite simple as the steps below will indicate.

1. With a data file loaded into the index directory, click on the index you wish to view. This should highlight it.
2. Next click on the **VIEW NAME** button.
3. The selected record should now be displayed.
4. As an alternate method, you can double-click on an index in the index directory and it will be displayed.
5. Finally, if you have a record already in view, you can click on the index entry to highlight it, then by clicking in any of the text boxes above will cause the selected index to be displayed. The purpose of this function is to prevent an index being referenced for one record while another record is edited.

### **EDITING A RECORD**

Editing a record is a simple process that involves the steps necessary to view a record, make the desired change, then storing the record. To make a change to a record, follow these steps.

1. Select an index and display the record using the previously mentioned methods.
2. With the mouse or tab control, move to the text box that you wish to change. When using a mouse you can click at the location of the desired change. When using a keyboard, use the tab and cursor keys to move the cursor to the location where you wish to make the change.
3. Make your desired change to the displayed data.
4. When complete with the change, click the **STORE NAME** button to save your change.

You will see as the record is stored that all the fields are cleared in the process. This is an indicator that the change has successfully taken place. To make more changes, follow the steps again.

### **SAVING VERSUS STORING**

When you work the an Address Book data file, the process of adding, deleting, and storing records creates duplicate records that are tacked on to the end of the data file. You will never have access to these files since internal program pointers reflect the current upper limit of valid data records and do not show these duplicated records. When you select a new file to open or exit the program, these duplicated records are deleted and the file is cleaned up and saved. As a general housekeeping measure though, selecting the **SAVE** option from the File menu will perform this function and still remain in the active data file. This is a wise move if you are doing extensive maintenance on a data file.

### **DIRECTORY INDEX SEARCHING**

You will notice the Address Book does not have an elaborate search system for the directory index. Up till now we have had to use the scroll bars to scan through our index list to find a record we want. This could become very cumbersome and slow when working with a large file. The feature here to quickly search or scan through our index listing is very similar to the Windows Help System Topic Search function. You will see a text box immediately above the directory index list box. From this box we can enter search strings and the directory index will display the first match it finds. With every letter that's entered into this box, the search becomes more accurate and closer to our desired string. To illustrate this procedure, open the

sample.abk file from the address book. You will see that we have a directory index list that is long enough for us to require the use of a scroll bar. Our desired target for this example will be Ulti-Mate Software Development. When we entered this record into the file, we used an index of **software**. We want to quickly go through the list and select this item to display. Using the scroll bar will accomplish the job, but what if we had a list with several hundred entries. That would be extremely slow. Follow the steps when using the sample file to see how this function gets us to our target name rather quickly.

1. Open the data file called **sample.abk**, this is a long list with our target well out of view.
2. Click on the search text box above the directory index to place the cursor in this box.
3. Type the letter **S** which is the first letter of the index we want to see.
4. You will see that the index **software** is now selected and can be viewed by clicking the **VIEW NAME** button.

While you are entering a search string in this box, every time a new letter is added the directory index will display the first entry it finds that matches the specification. If no match is found, no index will be highlighted. This feature allows us to go through the alphabet quite rapidly. For example, if we know the target index starts with the letter **S** for example, by entering S into this box, the first entry that starts with the letter S will become highlighted. If our search spec is now changed to **SA**, then the first index it finds that start with the letters SA will be displayed. This is a very useful feature and now you should experiment with this feature in the sample file before proceeding.

# Address Book Features And Options

## USING THE SEARCH BOX

The Search Box provides a means to create additional data files from another data file based on the search specifications you select. You can also have the data written to a **Last Search** data file for temporary use. This file's contents is maintained until another search is initiated. Finally you can have the search data output to your printer. All three options affect the contents of the lastdrch.abk file so remember that this file is only a temporary storage area to hold to data in. Currently wildcards are not supported in the search string. If public response to this program is good we will add wildcard and advanced search methods in future upgrades. As a final note, the search string is compared to the selected field from beginning to end. For example, if you select city and enter the string **om** as your specification, the search will find and store **Omaha** but will not store **Colombus**. Since address book entries are usually very basic entries, there should be no need for advanced search methods, however again we will say if public response requests it, we will add it for you. To perform a search, you will need a data file to create. For our example, we will use the sample.abk file again. There is no need to open the file prior to conducting a search as you will be prompted for a search filename and a save filename as necessary. We will cover search using the **NAME** field and store it as a **LAST SEARCH** data file.

1. From the Options menu, click on **SEARCH**.
2. Select **City/State** from the Search By frame.
3. Select **Last Search Data File** from the Write Search To frame
4. For our example, we will add the string **Bellevue** for our search specification.
5. When ready, click the **SEARCH** button to begin the process.
6. An Open File dialog box will appear. This box is to select the file that we want to conduct the search in.
7. For the example, we will open the sample.abk file. Click on this filename and then click on the **OK** button.
8. The search will begin and when complete you will be back at the main display screen. If the search was successful you will see nothing out of the ordinary and your data will now be in the lastsrch.abk file which can be opened like any other data file. If no matches were found, you will see a small message box appear stating so.

If you selected the printer as your destination, the search data will be output as it's found. We recommend having the Print Manager active for this feature to prevent the program from pausing and waiting while printing. Plus even if your printer is off or not on-line, the file will be stored there for printing at a later time. See your Windows manual for more details on using the Print Manager. If you selected Permanent Data File as your write file destination, you will be prompted for a filename to save your search file as. What will occur is that your last search data file will be renamed as the permanent data file. Consequently you will no longer see this file in your directory until you perform another search utilizing the last search or print option. If you attempt to print the last search data file, the program will create it for you however it will contain no records to print and you will receive a message box stating so. Remember the last search file is temporary in nature and by the action of saving this file with a permanent filename, you have eliminated the need for that particular search data that the file contained. While at first your search options may seem limited, this is not necessarily the case. You have the ability to create one large telephone directory and from it spawn smaller more specialized ones. For the home PC user, this should be more than adequate. For a small business that keeps customer lists and telephone numbers, the Address Book has enough options to create and maintain a functional and efficient database. The key to keeping a good database is to develop a single format to enter your data in. If you will be using a modem with this program, the the telephone number entry will require the most stringent adherence to the format you develop.

## TIME/DATE DISPLAY

The time and date display is a convenient option to give you a constant readout of the current system time and date. The display can be toggled off if you already have a utility in use that displays these items. Additionally, toggling the display off frees up some processor time (however small) which can help increase performance when tweaking your system in 386 Enhanced mode.

### **CONFIGURING YOUR MODEM**

To use your modem with the Address Book, you will need to create a configuration file to store your settings. A file with a sample default configuration is included with the package. If you should delete this file for one reason or another, you will get a message box when loading the program stating you must create another one. The file is called sercomm.cfg and should be placed in the current directory that the program is running in. To configure your modem, choose **MODEM SETTINGS** from the Options menu. The blocks to include are fairly self explanatory and the default setting should work for most modems. If not you can experiment with different strings to get your system to work. Currently the baud rate frame serves no useful purpose as a baud setting is not required to command the modem to dial a phone number. However with an eye to future use, we have placed the frame in the window and developed the shell controls necessary to specify a baud rate. Current plans for the Address Book might include the possibility of a simple but convenient E-Mail system between different users of the Address Book. Once again, public response to this program will determine if these upgrades are ever implemented.

Changes to your modem configuration are used immediately and there is no need to close and reopen the program to activate them. There is a concern about the reliability of using COM 3 or COM 4 under Windows. Adequate testing can not be performed for any ports other than COM 1 or COM 2. If you experience any problems or even have success using these ports, please do us an immense favor and let us know. To configure your modem, follow these steps;

1. Click on **MODEM SETTINGS** from the options menu
2. Select the comm port you will be using from the Port frame
3. In the Modem Commands frame, enter your preferences for the different command strings required. Our suggestion here is to keep it simple. During the development of this program, various options were tried and some had very undesirable effects. Remember that you just want to dial a phone number, not establish an MNP or v42 link.
4. When all settings are entered, click the **OK** button and your all set to go.

If you are unsure of what command strings to use, first try the default settings. These are the most basic commands that can be sent to the modem and should work for all Hayes compatible modems. Once you get the dial function to work, than you can alter the volume and dialing speed to suit your taste.

### **THE NOTE WRITER**

The note writer is nothing more than a scratchpad to leave temporary notes to yourself or to others who may be happening to use the program. The contents of each note page are stored only for the life of the program. That is, when the program ends, all notes are deleted. They are there for the sole reason to leave a reminder for yourself or to take a temporary message during the Address Book session. If you require a more permanent function, than use the memo writer or the Notebook included with Windows. Page control is through a set of small buttons located on the lower right hand corner of each note. Actually these are not true buttons, only pictorial representations of buttons. Using the note writer is very easy. To start, follow these steps;

1. Click on **POST NOTES** from the Memo menu.
2. The note page will appear on your screen.
3. To enter a message, just begin typing.
4. To save a note and return to the main display, you will see a small button with a book on it. Click on this button and you will return to the program. If you entered text, than that text will be stored automatically for you and the Notes indicator will illuminate indicating you have notes waiting. If no text was entered, there will be no storage and no indicators.
5. To enter multiple notes, call up the note page as mentioned in step 1, enter your first note. On the lower corner next to the Book button, you will see a small forward read button. Click on it to go to the next page.
6. You may enter the next page of notes. You will also see now that a backward read button has

appeared. To go back to the previous page you can click here. When done entering notes, click the Book button to return to the main display.

Whenever notes are waiting, the indicator will be lit advising you of such. You have no control over the notes other than adding new ones or deleting all the notes at once. Remember this function is only for quick little reminders and it shouldn't be necessary to have the full file system controls that are available with the Windows Notepad. After you have entered a note, clicking on the Post Notes menu again will allow you to view those notes. To enter another note, either delete all the notes or click on the forward read button till you come to a blank page and enter it there. The forward and back buttons can be used to cycle through all the notes. When you are complete with the notes or wish to delete the present ones, follow these simple steps.

1. Click on **DELETE NOTES** from the Memo menu and the note pad will be cleared and ready for new entries.

2. The notes indicator will then go out indicating you have no notes waiting.

You will notice at the bottom also is a label containing the time the note was left. This was added as a user convenience and cannot be changed. When you exit the notepad, the time that is stored with the note is the time that you actually exited the function, not the time you first called up a note.

### **THE MEMO WRITER**

The memo writer takes up where the note writer left off. If you need to make a permanent note which you can save to disk, than use this option. While the memo writer does indeed have a print function, the printed output is not formatted and really can't be recommended in place of the Windows Notepad. While you do have limited font support, this is for display only and does not affect the printed output. Once again, we did not add these to compete with the Windows accessories that came with the system, instead we wanted to give you an option where you could enter and store rough text notes without having to open the Notepad or Write program, or any other editor you might be using. To begin using the memo writer, follow these steps;

1. Click on **MEMO WRITER** in the Memo menu. In a couple seconds, the memo editor will appear.

2. It's very unremarkable in appearance and is purposely designed so. We tried to make it as easy as possible to use.

3. To begin using the editor, simply start typing.

4. To save your memo, click on the Save option from the File menu. You will go through the normal file save process of entering a filename and such.

5. To read a previously stored memo, click on Open in the File menu. A File Open dialog box will appear and from that you can select your memo to load.

6. To start a new memo, click on New in the file menu. When ever any memo activity required the save option to be called, the memo indicator will light to show new memos have been added. Since this is slightly different than the notes indicator, you can reset this indicator by clicking anywhere over the area of the icon.

7. Finally, to print a memo, click on print. This will only print the currently opened memo.

8. The edit commands, Cut, Copy, and Paste, function the same as in other Windows applications.

9. To change fonts, click on the font menu. The current selection will be checked and you can change it to any other item in the menu. Note that this will cause a global font change, not from just that point on.

10. To change font size, click on the Size menu, and choose a new font size. The current selection will be checked. This too will invoke a global size change.

11. Finally, to change style, click on the style menu and choose your option.

Again, font support including styles and sizes is not extensive and doesn't need to be when you look at the context of what the memo writer is to be used for. Remember these are not designed as replacements for any Windows text editor, only as a simple time saving accessory that has a use in the Address Book.

**INFORMATION MENUS**

The information menus, under the About menu, will provide a little information about the program and about our company. Yes they're added more for ego purposes than anything else but look at it this way. If for some reason you destroy your data file, you at least will still have the number for Ulti-Mate Software and can call and tell us about it.
